U.S. Foreign Policy Hit By Speaker

United States foreign policy regarding the newly formed countries of Africa and Asia is vague and ineffective, Dr. Haridas T. Muzumdar told the Klamath Knife and Fork Club dinner meeting Wednesday night at the Willard Hotel.

The doctor is a self-avowed friend and biographer of Mahatma Gandhi and is now on leave from Cornell University. He also said that the "vocal element" of the East favors the Soviet Union because it has stated that it was against "imperialism and foreign domination."

"The U.S. has never asserted itself as being for the masses of India to overthrow British rule," said the man whose topic was "India, Asia and the United States."

"Nowhere in either Democratic or Republican platforms has there ever been any mention that we were in favor of self-government for India." He said that is the reason the intelligentsia of the East tends to be pro-Russian.

"After World War II, when we had a chance to promote goodwill and understanding in the Middle East, what did we do but allow the British to go back to Malaya, the French to Indochina and the Dutch to Indonesia, and even sent the French one million dollars in military supplies per month to keep the Indo-Chinese under domination."

One bright spot that has appeared in our foreign policy, according to Muzumdar, is the selling of America to the Philippines by our school teachers. In the Philippines, he said, "Our school teachers did a good job."

He stated that we are missing many opportunities to sell the rest of the world on what America really means. He said that we should not underestimate the power of private enterprise in its endeavor to sell Americanism.

"On two days a year we should keep our embassies open and invite the people of foreign lands to break bread with us. Those two days are the Fourth of July and Thanksgiving."

The doctor explained that when he was in Turkey on the Fourth of July the embassy was closed and he opined that this would have been an excellent opportunity to keep our doors open to show these people what we are and what is meant by America.

Sitting with the court will be the county fair board led by Chairman Bryant Williams. The celebrations council was incorporated this year for the purpose of organizing a series of events staged over a week and culminated by an amateur rodeo. The roundup association is a group of long standing which has been in charge of the annual Fourth of July professional rodeo.

Conflict arose between the two groups when several local cowboys asked that amateur events be added to the professional contest and that the roundup association admit new members to their board of directors. Eventually the celebrations council resigned in their favor. The county court was asked to arbitrate the dispute.

Negro Baseball Star Rejected As Neighbor By SF Residents

SAN FRANCISCO (AP) — Willie Mays' attempt to buy a home here failed Wednesday because he is a Negro.

The spectacular 27-year-old San Francisco Giants centerfielder offered the \$37,500 the owner asked for a new house at 175 Miraloma Dr., but was turned down after a wait of several days. The owner said there was great neighborhood pressure against the deal.

Walter A. Gnesdloff, who is still offering the house at the same price—but not to Mays—said:

"I'm just a union working man and I'd never get another job if I sold this house to that baseball player. I feel sorry for him, and if the neighbors say it would be okay, I'd do it."

Gnesdloff, a small-scale builder and contractor in the upper middle class area, said two property owners he works for put pressure on him not to sell to Mays and neighbors objected by telephone.

"I've never been through this kind of stuff and I'm not even mad about it now," the normally exuberant "say hey kid" said Wednesday night.

"I'd sure like to live in San Francisco, but I didn't want to make an issue about it."

"I figure if a guy has his own problems he's got to lick them himself, and if neighbors don't want you, what's the good of buying?" Mays continued.

"But talk about a thing like this goes all over the world, and it sure looks bad for our country." Mays' wife, Marguerite, wasn't quite as philosophical about it. "Down in Alabama where we come from," she said, "you know your place, and that's something, at least. But up here it's all a lot of camouflage. They grin in your face and then deceive you."

Mayor George Christopher declared, "what's happened is not in accordance with San Francisco's traditions."

The mayor said "it's not our practice to preclude anyone's living where he wants to, regardless of his race." But he pointed out that "on the other hand, no law requires an owner to dispose of his property."

One of the property owners Gnesdloff said he worked for, Martin Gaewhiler of 148 Miraloma Dr., said "certainly I objected" to the sale.

"I happen to have quite a few pieces of property in that area and I stand to lose a lot of colored people move in."

Gaewhiler denied that Gnesdloff had ever worked for him and said he didn't force the contractor to do anything. "I told him to use his own conscience, but that he'd get a bad name if he went through with this."

The property owner added, "I certainly wouldn't like to have a colored family near me."

Auto Wrecks Claim Three

Two Oregon highway accidents killed three men Wednesday night.

A southbound station wagon sped head-on into a loaded logging truck about 12 miles south of Roseburg on the Pacific Highway. The two occupants of the lighter vehicle died.

According to Robert Ganz, Myrtle Creek, Douglas County deputy coroner, papers found at the scene identified the victims as Frank James Connell, 30, Medford, and James Ronald Van Winkle, 21, Cle Elum, Wash. Connell was the son of Ann Connell, society editor of the Eugene Register Guard.

The truck demolished the station wagon which, Ganz said, apparently was driven by Connell, a salesman for the Lee Johnson Co., a Portland appliance firm. He said indications were that Van Winkle had hitchhiked a ride with Connell.

The truck driver, George Heath, 24, Myrtle Creek, suffered minor injuries and was released from a Myrtle Creek hospital after treatment.

Max Walker, 49, Hood River, was killed after he wandered onto the Salem-Portland Freeway 20 miles south of Portland. Witnesses said they had seen him waving his arms running along the road.

David Carmichael, 26, Seattle, said the man suddenly leaped in front of his car and he could not avoid hitting him. Carmichael was not held.

The three deaths increased Oregon's traffic fatality toll for the month to 21 and for the year to 396, according to the Associated Press tabulation.

Marine Draws Brutality Rap
YOKOSUKA, Japan (AP)—One U. S. Marine was convicted and another acquitted today as the Navy began trials of 16 Leathernecks accused of brutality to brig prisoners at Sasebo naval base.

Cpl. Glenn W. Fredericks, 21, Fleetmute, Alaska, was sentenced to 14 days at hard labor and reduced to private rank for punching a sailor while Fredericks was on guard duty in the Navy brig at the south Japan Navy base.

The conviction and sentence are subject to review.

A similar charge against Cpl. Dayton W. Dierksen, 21, St. Lawrence, S. D., was dropped when the complainant, fireman Carlos E. Vota, 18, Amarillo, Tex., told the court he could not remember being hit by the Marine. Dierksen is due for discharge from the Marines Friday.
