

New Mouse Problem Told

TULELAKE—A new and more serious invasion of field mice than the one that cost farmers of the Klamath Basin an estimated five million dollars in crop damage in 1957, is sweeping the southern part of the Tulelake Basin, Ken Baggett, Tulelake farm adviser, said today that this second infestation is "much worse" in some sections near Tulelake, principally the Southwest and Sump area, the Panhandle and in part of the Popcock Bay district where the crop is principally hantchen barley.

The new crop of mice showed up about two and one half weeks ago and since then colonization has materially increased and herds of the rodents are now moving from infested to clean fields.

To date the heaviest invasion is confined to grain lands, to alfalfa fields and to large acreages of blue grass being grown for seed. Last year loss in potato fields was also heavy.

Many of the fields this year are first riddled, Baggett said, and first cutting of hay must be completed in the damaged fields before it is ready to permit immediate poisoning.

Farmers may poison for mice under the supervision of the agricultural commissioners of Modoc and Siskiyou counties but as yet no unified action has been taken by any other agencies.

Seth (Jack) Kirkwood, vector control officer of the California Department of Public Health, who spent some time here last year studying the possibility of the rodents having tularemia, returned here this spring to find a high population of young mice and pregnant females.

In last year's infestation, U.S. Public Health Department officials, state and county officials of Oregon and California and agricultural experts of Klamath County in Oregon and Siskiyou and Modoc counties in California, combined efforts to combat the rodent menace.

To date, C. A. Henderson, Klamath County agricultural agent, said no serious threat to crops in Klamath County has as yet developed.

WASHINGTON (UPI) — Senate Republican leader William F. Knowland announces that the Navy and Air Force have awarded contracts totaling 15 million dollars to California firms.

Knowland said Monday that Navy contracts to California firms included North American Aviation at Downey, \$4,250,000 for development of a missile control system; \$5,470,000 to Hiller Helicopters, Palo Alto, for production of H23D helicopters; and \$5,099,000 to Aerojet General, Inc., Azusa, for production of aircraft rocket engines.

The Air Force award was \$779,500 to Gresham Construction Company, Santa Clara, for building 48 family housing units at Travis Air Force Base.

Knowland joined with his colleague, Sen. Thomas H. Kuchel (R-Calif.), in requesting \$200,000 for an early study of California's Hidden and Buchanan reservoir projects.

They placed their request with the Senate Appropriations Subcommittee on Public Works. The money, if approved, would go to the Army Engineers to review the projects, which affect San Joaquin Valley.

Chamber Tells Banking Debits

Bank debits as reported by the chamber of commerce here for the first five months of this year totaled \$138,195,703 — up markedly from the same period a year ago.

The chamber also reported that receipts in the five month period of \$120,699, compared to \$113,006 in the comparable 1957 months.

In May, the chamber said, 45 new families moved to this area, bringing in 89 adults and 78 children.

Medo-Land Creamery Tells Merger With Meadow Gold

The merger of Medo-Land Creamery Company and Meadow Gold Dairies has been announced in a joint statement by Gordon Coleman, general manager of Medo-Land Creamery Company and William G. Karnes, president of Meadow Gold Dairies, Chicago, according to W. T. Bud Franklin.

Coleman will continue as general manager with headquarters at Eugene, Franklin said, and there will be no personnel changes at the four Medo-Land units.

"Actually, we regard this merger as an investment in the future of our community," Franklin declared. "It will enable us to keep pace with growth without sacrificing the high standards of quality and service which have contributed to our rapid growth in recent years. And, of course, we will continue to buy all our raw milk from the Klamath Basin Grade A Producers Association," he added.

Medo-Land Creamery Company, which maintains headquarters in its plant located at 675 Charnell Street, Eugene, and operates plants at Bend, Corvallis and Klamath Falls, retains its identity with the same officers, management, personnel, locations, products, brand names, distribution and manufacturing processes. The company is engaged in the processing, sale and distribution of bottled milk and cream, cottage cheese, butter, ice cream, Mellorin, other frozen desserts and fruit ades and carbonated beverages.

Medo-Land Creamery Company was organized in 1931 when Ray C. Smith purchased what was then known as the Corvallis Creamery Company which had plants in Eugene, Corvallis, Bend and Roseburg. Smith and the participating partners, D. M. Lay, R. C. Woodruff, F. Moser and Frank Strong changed the name of the new firm to Medo-Land Creamery Company.

At present, the four units employ some 250 persons and operate more than 125 delivery trucks in these areas.

Meadow Gold, currently observing its 60th anniversary Diamond Jubilee, is one of the nation's leading processors and distributors of dairy foods through the West and Middle West.

"Through the new association, Medo-Land will have the added advantages of Meadow Gold Dairies' excellent quality control facilities, research and development laboratories, test kitchens and exclusive formulas," Franklin said.

Shareholders of the First National Bank of Portland voted to change the name of the institution to First National Bank of Oregon Friday afternoon at a special meeting held in Portland. They will request the controller of the currency to issue a new certificate to effect the change on August 1, C. B. Stephenson, bank president said.

"Today, First National Bank services are available to the citizenry of Oregon and to all segments of our state and its economy and it is certainly appropriate that the word Oregon be directly associated with the name of our bank," Stephenson said.

"With 77 banking offices serving 55 Oregon communities it is truly a statewide institution and can best be described by a title which indicates the breadth of service extending beyond the confines of Portland," he added.

When the bank was organized in 1905 and granted the first national bank charter west of the Rocky Mountains, the original articles of association requested the name "The First National Bank of Oregon," but the articles were returned with "Oregon" scratched out and "Portland" penned in its place, the bank president explained.
