'Onkel Paul' Back In Town; GI Returns To Aid Children

DAHLBERG, Germany (UPI)—"Onkel Paul" is back in town. "Onkel" is German for uncle and in this case is Sgt. Paul Kirby, 45, Fresno.

It's not difficult to realize Uncle Paul's back in this small community near Aschaffenburg, some 30 miles from Frankfurt. Just ask the local German kids where they get their ice cream and they'll tell you it came from their American uncle.

Kirby, still single, first adopted his uncle-soldier role while fighting in Europe with the 75th Infantry Division in World War II. Alongside his wartime duties he was constantly reaching in his pocket for goodies of some kind or another for small children.

"You never quite get over something like that," Kirby said. "War hurts kids most of all, and they are the most defenseless."

After the war, Kirby went back to Fresno and eventually became chief clerk and office manager of the Hotel California. In 1951, he quit his job and came back to the Army, which promptly sent him to Germany and an assignment at Aschaffenburg with the 1st Infantry Division.

Dahlberg became his haunt, and he found his affection for German children undiminished by the nation's improved economic situation.

"Do kids ever get enough ice cream?" he said laughingly.

"Onkel Paul," visiting German friends in Dahlberg on passes and leaves, became a kind of unofficial American ambassador. When greeted by children in the streets, he gave them money for an ice cream cone. Sometimes he took them into a nearby tavern for a lemonade and on Sundays he rounded up all the children and took them to church.

Adults honored him by making him the only American member of the Dahlberg Raucher Club, a smoker's fraternity.

Kirby returned to the United States in 1955. "But I'll be back," he promised his friends.

Now Kirby is on his third European tour, stationed with 7th Army's Recruiting Section in Aschaffenburg. And naturally, the first place he headed for on his first pass was Dahlberg.

"The word I was back spread pretty quickly around town," he said.

"I was surprised all the kids recognized me. They had never seen me in civilian clothes. All those kids I gave ice cream to remembered me. I was amazed."

To celebrate Kirby's return, 50 children staged a "Hello, Onkel Paul" party.

And the German press and radio were on hand to record the town's greeting to its favorite American.
