

Weed Youth To Serve Time On Weekends

WEED — Robert Evans Trowbridge, 22, Weed, was found guilty in the McCloud Justice Court Wednesday on misdemeanor traffic violations of reckless driving, driving on the wrong side of the roadway, and running two stop signs in McCloud on December 20.

He was sentenced to serve 16 days in the Weed sub-county jail, to be served weekends, crediting two days each for the next eight succeeding weekends.

Kenneth T. Stone, judge of the Weed Justice Court, presided at the trial replacing Judge Merle Hanson of the McCloud Court who had disqualified himself as having been a witness to the crime.

A. M. Caselli, McCloud, signed a citizens complaint for Trowbridge's arrest after witnessing the incident along with numerous McCloud citizens.

Testimony given at the trial by six witnesses related a vehicle operating in a reckless manner, running two stop signs in McCloud, nearly overturning on a turn in front of the McCloud service station and proceeding in a reckless manner.

When the same vehicle returned from the opposite direction, Judge Hanson, who was in the station when the auto first passed, stepped out to the roadway and attempted to flag the driver down, according to testimony.

Trowbridge, who was identified by two witnesses as the driver of the vehicle involved, made a pass at the judge with his vehicle and proceeded out of town without stopping, witnesses said.

The vehicle license number was taken by other witnesses at the scene as well as by Judge Hanson.

Albert H. Newton Jr., district attorney, was the prosecuting attorney and Trowbridge was his own counsel.

County Names Welfare Chief

YREKA — Wilbur M. Van Over, welfare director of Amador County, was named by the Siskiyou County Board of Supervisors as the new welfare director for Siskiyou County, and will assume his duties on March 1 at a salary of \$530 a month.

Van Over is succeeding Mrs. Caroline Nixon, who was appointed to head the department on a temporary basis by the Siskiyou board, at the time that Mrs. Dorothy Hill resigned the post last May. The board expressed reluctance at employing a successor for Mrs. Nixon as they felt she was doing a commendable job, but according to state rules, Mrs. Nixon was not qualified legally for the examination for the position, since she lacked a few weeks experience as a welfare director.

Van Over, who has been welfare director for Amador County since 1957, had previously served as a welfare worker for nine years for Stanislaus County. He is 35, married, and father of a 10-year-old daughter. Van Over's background also includes his service during World War II with the Navy; he graduated from Modesto High School and Modesto Junior College. He is a member of the Masonic Lodge, and Lions Club, and director of the Amador Tuberculosis and Health Association.

John C. Henderson, district representative of the State Department of Welfare, was present at the Tuesday meeting of the supervisors, and he commended Mrs. Nixon on her fine work as a temporary director. He further stated that Siskiyou County Administrator Jess O'Roke and Mrs. Nixon should be equally credited for having kept administration costs below the state average in connection with county aid. Henderson further stated that welfare expenses are higher than average in Siskiyou County, due to an unusually high number of old people who are entitled to county aid.
