# Ranger Tells Visitor Hike

LAKEVIEW — Hunter-use trend continues to increase on the Fremont National Forest, according to Clayton Weaver, supervisor, in a review of 1958 visits on the forest. The total number of visits for the past year was 139,190, as compared with 120,600 for 1957. Of the six ranger districts reporting, the Warner District shows the most substantial increase, with Bly and Silver Lake districts also showing significant increases. By use categories, the gains were shown to occur in hunting, where fishing pressure fell off some in the forest area. It is believed that the opening of the sage hen season, together with the first hunters choice deer season in the Warner District area accounts for the increase there.

Plans are moving along on schedule, Weaver said, for increasing and improving facilities to accommodate present and anticipated recreational use. Some 40 tables, eight toilets, and 10 precast fire grates will be constructed this winter. One well was drilled to provide water at Thompson Reservoir where a new camp area has been constructed, and contracts have been executed to have wells drilled at Deadhorse and Campbell Lake areas. The Fremont Highlanders, an operating permittee of the Fremont, has added an additional rope tow on the winter sports area about nine miles from Lakeview on the Warner Valley Highway. During the summer months Lakeview residents and tourists are reminded by the supervisor to visit the newly developed North Warner viewpoint, reached by way of the North Warner Road, where a very fine view of the Big Cove Valley can be had from this lofty vantage point.
