

Fairgrounds Bidder Told

TULELAKE — Successful bidder for the construction of a maintenance building on the Tulelake-Butte Valley Fairgrounds here is Gibbons and Zick of Alturas. Bid on the 32 by 100 foot buildings was for \$19,987.

Bids were opened at the annual meeting when Paul Christy, Tulelake, was elected president of the board of directors. Bill Ganger was named vice president and William Whitaker will continue as secretary-manager.

Whitaker in his annual report, indicated the steady growth in attendance from 4,500 in the opening year of 1952 to 15,137 in 1958. Premium money in the same period increased from \$2,492 to \$9,071.

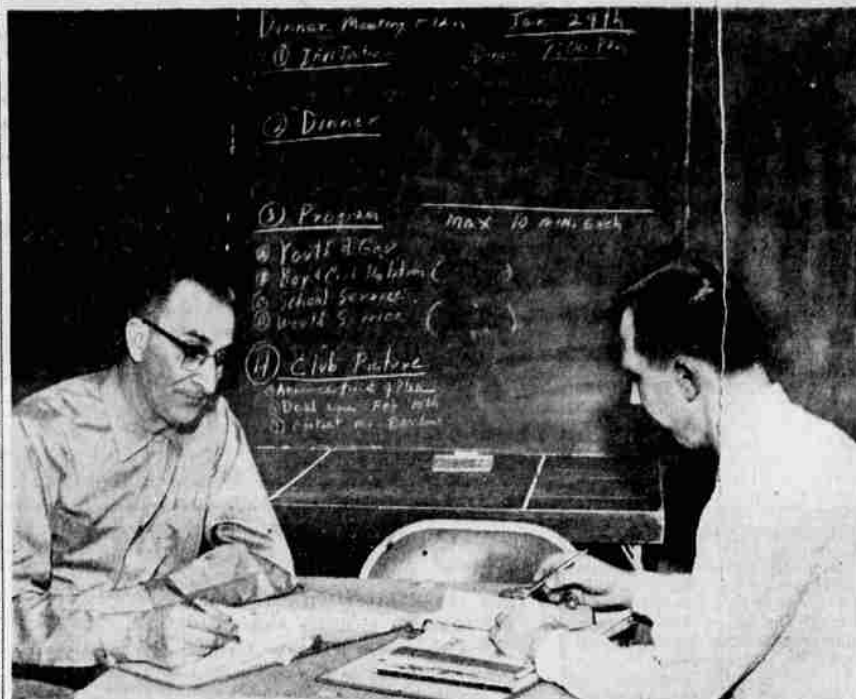
Scheduled for building this year in addition to the maintenance building are livestock chutes and holding pens for future rodeos.

Whitaker further reported that the fairgrounds has been used 226 days by 18,000 persons not including fair dates. The fair board employed 70 persons during the last year with a total payroll of \$17,954.38.

Rainier Drops Constitution

MONTE CARLO, Monaco (UPI) — Prince Rainier suspended Monaco's constitution today in a sudden move against Republicans opposed to his absolute rule.

The Prince announced the indefinite suspension of Monaco's constitution in a suddenly scheduled broadcast which interrupted Radio Monte Carlo's usual stream of commercial and hit parade records.

In stern tones the Prince announced he was suspending the work of the Communal Council and the National Council—the two bodies which run Monaco's internal and external affairs—because of the Communal Council's refusal to consult him.

The suspension meant the Prince himself would be the government of Monaco until further notice.

The Prince's action followed speculation in a French newspaper over the possibility of a "little coup d'etat" in the tiny principality.

The French speculation had been considered largely whimsical since few here believed any serious threat existed to Rainier's rule.

Rainier is one of the world's few remaining absolute rulers.

Last year the Municipal Council asked him to delegate some authority to it and Rainier agreed on condition the council would report on its work to the "government"—to Rainier himself.
