### Girls, Murder Involved In French Inheritance

PARIS (AP) — A scandal involving bribery and murder plots over inheritance of one of France's biggest fortunes, is gripping the interest of Paris. Every paper is packed with it. It has touched off speculation that people in the National Assembly and perhaps in the government may be tainted by the affair. Mingled in the scandal are two beautiful call girls and a rich widow, heiress to two massive fortunes and a whopping art collection. The fortune in the widow's hands is variously estimated by the newspapers at around 120 million dollars. The fall guy is a 24-year-old former paratrooper, who fought bravely in Algeria and also won a reputation for dissipation. He is Jean Paul Guillaume, adopted son of Madame Dominique Walter. She inherited the fortunes and put her brother, Jean LaCaze, in charge of a big lead and zinc mine in Africa. The story hinges about alleged attempts of Madame Walter and her brother to get rid of the adopted Guillaume who — unless dead or ruined in reputation — will inherit a big part of the fortune. She long ago turned cold to the son she adopted. During the 1920s, Madame Walter, a girl so beautiful she made even painters gasp, made her way into artistic circles. She married Paul Guillaume, an art dealer, and they amassed a fortune dealing in art. In 1934 art dealer Guillaume died. The widow needed an heir to ward off grasping relatives. Soon baby Jean Paul appeared in the household and in 1941 she formally adopted him. Soon afterward, in 1941, she married Jean Walter, the engineer. Although she grew cold to the adopted son, Jean Walter liked him and looked after him. But in 1957, Jean Walter was riding with Madame Walter and Dr. Maurice LaCour near Paris. Walter stepped out of the car and was hit by a passing automobile, and was injured fatally. That left her, and the adopted son heirs of the joint fortunes. At that point, begins the alleged plot. So far only one man is under arrest. He is Jean LaCaze, the brother of the rich widow. He has been accused by two call girls — one the sweetie of the adopted son — of offering big bribes last December if they would accuse the adopted son of procuring, or bringing in clients for prostitutes. If such an accusation were made to stick against Jean Paul Guillaume he could lose his inheritance. Under French law the adoption could be nullified by the rich widow if he proved to be of bad character. About a year ago the deputy mayor of Antibes, Camille Rayon, came to a judge in Paris with a strange story. He told the investigating judge — who in France acts as a grand jury — that a certain doctor Maurice LaCour had offered him about \$30,000 to kill the adopted son, Jean Paul Guillaume. LaCour is a close friend of the rich widow, and at present is with her in the Hotel Marmoulin in Marrakech, Morocco. Both have told reporters by telephone that the story is all a frameup by the adopted son. Rayon told the story to Judge Jacques Baigine. For some reason, the judge put the Rayon story on a shelf and left it there until last December. Then two call girls told similar stories.

PORTLAND (AP)—The \$250,000 General Motors Motorama Exhibit will be a feature of the Oregon Centennial Exposition here beginning June 10, the Centennial Commission announced Friday. Meanwhile, the Multnomah County Centennial Assn. said Portland would be gaily decorated for the Centennial—at a cost of about \$34,000. The decorations committee is planning on 400 hanging flower baskets for light poles, and the use of fountains at the entrances to the city.

### Gen. Marshall Has Papers Under Lock Until His Death

LEXINGTON, Va. (AP)—Stored under lock and key in the Virginia Military Institute's library are the personal and public papers of Gen. George Catlett Marshall. You could not buy them for a million dollars. That offer has been made and rejected. Marshall has stipulated that they cannot be published, in whole or in part, without his express permission or until his death. Historians feel sure the collection holds much hitherto secret information on events of the last 20 years. In this span Marshall served his country as the U.S. Army's wartime chief of staff, as secretary of state and as secretary of defense. What, for instance, are Marshall's views on the controversial issues of World War II? On his postwar mission to China, when he spent a year trying to mediate between the Nationalist and Communist Chinese? On the conduct of the "cold war" with Russia? And what does Marshall have to say in reply to the bitter personal attacks to which he sometimes has been subjected? Answers to these and many another question presumably lie hidden in the 155,000 original and microfilmed documents at VMI. Marshall has empowered the George C.
