Your Annual Income Tax Primer

Here's how to determine whether you qualify for the sick pay exclusion. If your employer has a plan or agreement with his employees that he will continue to pay them during absences on account of sickness or injury and, during 1958,

Sly Report Acceptable To Senators

Editor's Note: This is the third of four articles analyzing key problems in the 1959 Legislature. Another major report to be considered by the Legislature is the Flesher report calling for establishment of a series of educational centers throughout Oregon to provide two years education beyond high school.

Most legislators had not made up their minds on this report because they were not yet familiar with it. A good many legislators were for the report, but not in a red-hot way. Rep. Dick Hoyt (R-Corvallis) said "Some sort of junior college and vocational program is needed to relieve the load on higher education and such programs could well be partly financed with state funds."

Several legislators thought more study was needed. On another important education matter—increasing basic school support from \$105 to \$120 per census child, legislators were very skeptical of whether it could be done this session. Many agreed it should be done, but didn't see how it could be done without raising present taxes or creating a new tax.

Rep. Clarence Barton (D-Corvallis), chairman of the House Tax Committee, said he thought most of the Sly conclusions good, but would not go along with the Sly recommendation of no personal tax on capital gains if the asset is held longer than one year.

Barton thought this might result in high revenue losses that would have to be made up by the majority of Oregon taxpayers. He estimated the loss at six million dollars or more.

Most legislators thought a change to new excise taxes, new bases for income tax or a consumer sales tax, or a combination of these taxes would come slowly.

Birds Provide TB Cure Clue

WASHINGTON (AP) — Unique wax-eating birds in Africa have provided a clue which eventually may help control tuberculosis, the National Science Foundation says. In its annual report, the NSF said some of its contract scientists had found in the intestines of such birds a hitherto unidentified bacterium that produces a certain protein fraction. This protein inhibits the growth of tuberculosis germs in test tubes. Moreover, in preliminary experiments, it appears to protect guinea pigs against the TB germ. The bird is called the "honey guide" because it guides certain mammals, including man, to the vicinity of wild bees' nests. After the mammals forage such nests, the tiny birds feed on the waxy honeycomb, their chief source of food. While studying the digestion and nutrition of these birds, NSF scientists found a "wax-splitting bacterium" in the intestinal tract which apparently helps the birds digest their waxy diet. The scientists, knowing that the causative germ of tuberculosis has a waxy envelope, tested the effect of the protein fraction on TB germs.

East Bay MD Found Dead

PIEDMONT (UPI) — The body of Dr. Abilio Reis, 66, prominent East Bay physician, was found in his home Monday night — under nearly the same circumstances that his wife's body was found less than two weeks ago. Police attributed both deaths to an overdose of sleeping pills. The body of Mrs. Reis, 46, was found Jan. 21 in the furnace room of the house. An empty pill bottle and a glass lay nearby. Authorities said Dr. Reis had been dead since Saturday. His body was found lying fully clothed across his bed. Nearby lay an empty sleeping pill bottle, a glass, and an open diary that told of a recent trip to Africa.
