Extra Heart, Hustle
Little Man's Chance

NEW YORK (UPI) — Extra heart and extra hustle can make the little man a success in professional as well as college basketball. "Easy Ed" MacAuley of the St. Louis Hawks insisted to play in a studied sneer at statistics.

The facts, of course, would seem to belie the statement. Because MacAuley's own Slater Martin, a "midjet" of 5 feet, 10 inches, is the only man under 6 feet currently playing in the National Basketball Association. "Even so," MacAuley argues, "a man can be 4 feet tall and make the grade if he can do the things he's supposed to do."

In basketball, this would seem as improbable as Frank Sinatra taking a course at Slenderella or Willie Shoemaker playing Tarzan in the movies. But MacAuley from the top of his 4 feet, 10 inches, thinks that the smaller fellows accept defeat too easily. "Sure, the little guys need more physical ability, as well as added desire and dedication," he says. "The most important thing, however, is attitude. If the little man has the right one, he has more effect than all the physical endowments in the world."

If this is so, you might begin to wonder if Eddie Arcaro could be the heavyweight champion of the world or whether Bill Veeck's midjet might not have wound up a better centerfielder than Joe DiMaggio. But MacAuley takes a firm stand for the little men. "Look at Ben Hogan," he points out. "He could have been told that he was too little and too skinny to hit a golf ball with the bruisers. But he had the determination and will to win. Look at Don Hennon of Pittsburgh. A lot of people told him he was too small for college basketball at 3 feet, 8 inches. But you'll notice he'll get a lot of All-America votes."

MacAuley, on the other hand, admits that the basketball height level goes up and up each year and the big boys have to become ever more proficient. "Farmer's Sand and Gravel and the DeMolay Gold quintet each collected late in - the - game wins Wednesday night in Victory League competition at Mills School. The Farmer five, behind an 18 point effort by Don Hamilton, outlasted the R and R's 39-36, while Corky Kojowski piled up 20 points to head the DeMolay 38-33 victory over the Thunderbirds. John Hancock collected 15 points for the losing R-R quint while Gary Burt amassed 12 points for the Thunderbirds."
