

Fete Sated By University

FORT KLAMATH—Mrs. Elizabeth Loosley, Fort Klamath, Klamath County pioneer, will be present tonight at the annual canoe fete at the University of Oregon, Eugene, during the Class of 1960 Junior Week celebration.

Theme of the fete this year is "Oregon Trail Marks," and 11 cities in Oregon which are noted for their historical interest will be saluted at the fete. Among those chosen this year was the town of Fort Klamath, 37 miles north of Klamath Falls in the 160,000-acre Wood River Valley, an area of rich historical background.

Mrs. Loosley will be guest as representative of the town at all Junior Week events which will include the canoe fete, the all-campus luncheon and the all-campus sing. She will be introduced during the festivities with other town guests and with them will be the university's guest at the dinner to be given in their honor in the Erb Memorial Student Union building on the campus.

Mrs. Loosley, who has made a lifetime study of history and has written much in this field, was deemed well qualified by the invitation committee to represent Fort Klamath from a historical standpoint.

She is a member of the Oregon state and national historical societies, of the Wood River Pioneers and Old-timers and the Fort Klamath Civic Improvement Club. She owns and operates her own business in Fort Klamath, Loosley's General Merchandise.
