Stocks WALL STREET NEW YORK (AP) — The stock market closed mostly higher today. Aircrafts and sugars were down. Volume for the day was estimated at 3,400,000 shares compared with 2,970,000 Monday. Pivotal issues rose from fractions to about a point. There were scattered losers. Sugar stocks retreated on news of the Cuban agrarian reform program which seemed to ban all Cubans from shareholding in firms operating Cuban sugar plantations. Cuban American Sugar dropped about 3. American Sugar more than 2 and Vertientes Caguaguey sugar over a point. United Fruit, a big landholder in Cuba, fell about a point. Most electronic shares were higher although Zenith dropped about 9. Radio Corp. rose around 2. Chrysler was ahead around 2 and Ford more than a point. General Motors rose around a point. U.S. Steel and Jones & Laughlin held fractional advances. Du Pont recouped about 1. Good year and Lockheed rose around a point each. U.S. government bonds were steady to fractionally higher.

VFW Members Ask Veto Of Town Sale

YREKA — A resolution asking that the town of Tennant not be sold to private speculators by the National Veterans of Foreign Wars was passed by 100 members of District 29, VFW, at Yreka on Sunday. The International Paper Company had presented the town, including 100 homes with community facilities, to the veterans organization a few years ago. The town was to be used for pensioned veterans and their families, but for two years the town has been left unoccupied. The resolution stated that the national organization has a legal right to sell the town, but District 29 does not believe that they have a moral right to sell it. It also stated that the adverse publicity is injuring the prestige of the VFW. It was also stated that the town of Tennant should be withdrawn from the national council of administration of the VFW and that the matter be placed before the assembled members at the national convention in Los Angeles this year. Officers elected at the meeting were Delbert Haley, Yreka, commander; Raymond Neutse, Anderson, senior vice commander; Randolph Crowley, Mount Shasta, junior vice commander; Robert D. Arrastini, Redding, quartermaster; Ray T. Ellis, Weaverville, advocate; Robert Stier, Weaverville, surgeon, and Lester Bernal, Burney, chaplain. W. D. (Red) Houston, commander of Yreka Post 3813 and national aide-de-camp to National Commander John W. Mahan, installed the officers with the assistance of Joe Kemp, Weaverville Post 7705. Mrs. Flora-Lee Reeves, Dorris correspondent for the Herald and News, was presented a certificate of appreciation for her cooperation and assistance to District 29 in publicizing its activities throughout the Northern California area. Scott Valley Post was presented a \$25 check for its over 100 percent rise in membership. Citations for over 100 per cent membership were presented to Weed, Yreka and also to Scott Valley. Houston stated that Frank Jenkins, editor of the Herald and News and newly-elected honorary State of Jefferson governor, would be honored to know that Klamath and Butte Valley spuds will be labeled as State of Jefferson Spuds and will be served as such at the VFW dinner to be held in the new future in Weaverville. The next District 29 meeting will be held in Burney in August.

Condemn Bill Killed SACRAMENTO (UPI) — Legislation which would have given the state power to condemn land to public hunting and fishing areas was killed Tuesday in an Assembly committee. The Fish and Game committee rejected the plan by Assemblyman Don A. Allen (D-Los Angeles) after hearing vigorous opposition from farm groups and from individual farmers. Allen said his bill was aimed at permitting people to get to land which has been set aside for hunting and fishing. He cited cases where public fishing beaches were surrounded by private land. However, a parade of farmers objected that the bill would "chip away at the rights of land owners."

Music Concert Slated Thursday

Work Measure Held Invalid

SAN FRANCISCO (AP) — The State Supreme Court in two decisions Tuesday held county right-to-work ordinances were an invalid invasion of state jurisdiction. But the 4-2 decision in a Trinity County appeal "in effect gives us a state right-to-work law," declared an employer attorney. So-called right-to-work laws ban labor contracts requiring workers to belong to a union as a condition to holding their jobs. They also prohibit employers from refusing to hire persons because of non-membership in unions. The decision established a new ruling case on organizational picketing in California. The court, in a reversal of former decisions, declared the State Labor Code makes illegal union picketing of any firm where a majority of employees do not want to become union members. "In effect, this gives us a state right-to-work law," said Nathan Berke, California Assn. of Employers attorney. "It's not quite as broad as the proposition voted down in November, but it's mighty close." Justice Roger J. Traynor, dissenting strongly from the majority, said the four justices had "usurped legislative power." The court testing of the county measures started before the 1958 election campaign in which a state right-to-work proposition was a top issue. Democrat Edmund G. Brown opposed it and won the governorship. William F. Knowland, former U.S. senator running against Brown, backed the right-to-work proposition. Knowland was defeated by a wide margin. The court's six justices unanimously held that local right-to-work ordinances were invalid under the state labor code, "in substance a bill of rights for workmen in California."

Girl Kidnaper Sent To Jail

ALBUQUERQUE, N.M. (AP) — Betty Smithley, 16, was sentenced indefinitely to a correctional center after she pleaded no contest to a charge of kidnaping 18-month-old Mitchell Johnson. She was charged with taking him to Dallas where she abandoned him in a drug store. "I am very sorry I took the baby," the girl told U.S. Dist. Judge Carl Hatch Tuesday. "I would like to be sentenced somewhere that I would have a chance to get an education." Officials said she probably would be sent to the new Federal Girl's Youth Correctional Center in Virginia.

Ancient Judge Recalls Radio

LOS ANGELES (AP) — Barbara Beagle, 10, has a new \$500-a-week contract as a TV actress with NBC and a new fan. The fan: Judge John George Clark, who approved her contract Tuesday and humbly listened to Barbara's description of her TV role. "I'm going to play the role of Teeny—the one who comes up and teases Fibber McGee and says 'betcha—if you remember radio.' "Well, yes, I remember radio," the judge replied. "You just don't know how old I am."

Lee Kin Widow Dies At Age 84

ASHEVILLE, N.C. (AP) — Mrs. Robert E. Lee III, widow of a grandson of Confederate Gen. Robert E. Lee, died Tuesday night after a long illness. She was 84. Mrs. Lee, once prominent in Washington circles, was a direct descendant of Henry I. Middleton, first president of the Continental Congress, and Arthur Middleton, a signer of the Declaration of Independence. She was a granddaughter of Christopher Memminger, first secretary of the Confederacy under Jefferson Davis.

Governor's Labor Bill Tabled; Dies

SACRAMENTO (UPI)—The Senate Labor Committee killed one of Gov. Edmund G. Brown's labor bills Monday night by a 5-2 vote to table the measure. More than 700 farmers, dairymen and small businessmen packed the Assembly chamber as the committee debated and took action on the bill, which had been introduced by Assemblyman Allen Miller (D-San Fernando). The bill was a technical measure dealing with the rights of labor unions to organize, settlement of jurisdictional strikes, election procedures, and repeal of the present jurisdictional strike act. But to farmers the bill spelled trouble. Miller tried to explain that the farmers' fears were groundless. "This bill neither expands nor limits the rights of unions to organize," he said. "Not in agriculture, small business or any other field." Countering Miller's argument were more than a dozen speakers—some highly paid lobbyists for farm and employer groups, some of them tax-paying, hard-working dairymen or pear farmers. Typical was Mrs. Leo P. Hedegard, Modesto, a dairy operator. She wanted to object to a provision in the bill which would repeal the employers' present right to seek a speedy court injunction to stop a jurisdictional strike or picketing and substitute an administrative procedure with the Division of Industrial Relations as arbiter. "Milk is highly perishable," she said, "and you can't turn the faucets off on a cow." "Under present law, we can go to court and get immediate relief if we are threatened by a strike. Under this bill, before we get relief we'd be out of business." Mrs. Hedegard and other witnesses said it might take the state agency four or five days to act while a court injunction could be obtained in 24 hours. Although the bill represented one half of Brown's labor-management legislative program, three Democrats joined two Republicans on the committee to kill it. Democratic Sens. Robert I. Montgomery of Hanford, Alan Short of Stockton, and John J. Hollister of Goleta voted with Republicans Paul L. Byrne of Chico and J. Howard Williams of Porterville to table the measure. Voting against tabling were Democrats Richard Richards of Los Angeles and Stephen P. Teale of Westpoint.

Pat Approves Water Slate

SACRAMENTO (UPI) — Gov. Edmund G. Brown approved his compromise water program today despite numerous Senate amendments. After conferring with his top water lawyer, Ralph Brody, the governor said he feels the program, contained in SB1106, is in "excellent shape." The Senate amendments, said the governor, are "generally acceptable." The Senate Water Committee voted approval of the bill Monday night after three hearings. Sen. Edwin J. Regan (D-Weaverville), a leader of a group of northern senators who have been trying to win concessions, said he thinks the measure in its present form "is in pretty good shape." But another northerner, Sen. George Miller Jr. (D-Martinez) said the bill could lead to "daylight robbery" of water from the Sacramento-San Joaquin Delta, which is in his district. "The bill fails in any way to protect water users in the delta," Miller said. "Under this bill, water from the delta that has been put to beneficial use over many years could be taken away and sold to new users hundreds of miles away." Miller said he would press for amendments to protect delta interests when the bill goes before the Senate for debate, probably next week. In its present form, the bill calls for a \$1,750,000,000 bond issue to finance a statewide water program, mainly the Feather River Project to export northern water to southern California. It contains guarantees to protect the validity of water contracts. Northern Senate amendments include earmarking 250 million dollars from the bonds to build local or delta needs and includes language protecting existing northern water rights.

Man Pays \$100 For Contributing

YREKA — Tom F. Coble, 39, of Chemult, entered a plea of guilty at his hearing before Superior Judge James M. Allen here on Monday on charges of contributing to the delinquency of a minor. Judge Allen placed him on probation for one year and sentenced him to pay a fine of \$100. The charge grew out of an incident which occurred last March 20 involving the transportation of a 14-year-old girl across Northern California and leaving her at the Granada cut-off. Coble was arrested on a complaint filed on May 23 and his preliminary hearing was held on April 7 at which time the case was referred to the superior court.

Boy Dies

BUFFALO, N.Y. (AP) — A revolver in a dresser drawer, a boy's curiosity, an afternoon off from school, nobody at home. All these added up to death Tuesday for 14-year-old Ray Otto. He shot himself in the forehead while playing with his brother's .38 caliber revolver. His 11-year-old sister, Shirley, found his body

FORT JONES — Sandra Crader, daughter of Mr. and Mrs. Frank Crader, will be awarded the Anna Reynolds Willard Memorial Scholarship at graduation ceremonies of Fort Jones High School on June 3. The scholarship is awarded annually to a deserving student who plans to enter the field of teaching, and is a \$100 grant. The award was established in 1954 by the late Charles L.
