

Demos Housing Bill Passes By Whopping 261-160 Vote

WASHINGTON (AP) — A walk away victory by House Democrats in their battle for large-scale federal housing aids enhanced prospects today for other Democratic programs.

By a luster 261-160 vote Thursday, the House passed a Democratic-backed \$2,100,000,000 housing bill after upsetting every Republican effort to whittle it down to administration size.

The result put Congress squarely at odds with President Eisenhower in the politically tinged battle over spending versus the balanced budget.

A more immediate result was to generate new steam behind proposals for a billion dollars of federal aid for local public works programs.

jects, and a quarter billion dollars of government loans and grants to assist depressed areas. House passage of the housing bill now sends it to conference with the Senate to compromise differences. The Senate earlier this session voted a \$2,600,000,000 program.

Republicans were counting on a presidential veto if the bill sticks to present lines. None of Thursday's major votes gave the Democrats the two-thirds majority they would need to override a veto.

Presidential displeasure appears certain to be centered on authority for continuing government-subsidized low-rent public housing.

President Eisenhower in his January message to Congress asked for an end to public housing. But the Senate voted to subsidize 45,000 new units, the House 140,000 new units over four years at the rate of 35,000 a year.

The House ignored cries of "galloping socialism," budget busting and spending sprees in approving the bill without major change.

A coalition of Republicans and Southern Democratic conservatives was outnumbered by the disciplined Democratic majority on every key vote.

Democratic leaders, however, suffered a setback engineered by Rep. Albert Thomas (D-Tex.) on a proposal to end what he criticized as a "back door approach to the Treasury" on financing housing programs.

By a 222-201 vote, in which both Republicans and Democrats defeated party lines, the House said federal housing officials must justify their spending needs annually before the House Appropriations Committee.

The Medford Bureau of Land Management district office is going to sell by oral auction 1,312.000 board feet of Klamath County timber at 0:30 a.m. standard time June 11 at the office at South Riverside and Barnett Road, Medford.

The timber has been appraised at \$22,920 and bids for less than that amount will not be considered. A minimum deposit of \$2,300 must accompany bids.

It is located on the northeast quarter of the southwest quarter of Lots Three and Four and on the southeast quarter of the southwest quarter of section 19, township 38 north, range six east, near Buck Lake on the head of Spencer Creek.

The tracts contain an estimated 275,000 feet of Douglas fir, 25,000 feet of ponderosa pine, 18,000 feet of sugar pine, 702,000 feet of white fir, 231,000 feet of white pine and 60,000 feet of Shasta red fir.

An area of approximately 80 acres may be clear cut and about 20 acres may be partially cut. The contract will require a fire prevention and control plan, a logging plan, slash disposal plans and other stipulations.

Access to the area is provided by the Maggard and Walters Cabin Roads owned by the Weyerhaeuser Timber Company.
