BALTIMORE (AP)—Some crippled children may provide the impetus to bring Baltimore's second National Football League Title.

Every day at 5 p.m. a group of Colts invades the quiet grounds of Kernan Hospital. For the next hour or so the robust athletes exercise at or are tested by equipment designed to help the handicapped.

The work goes on under the watchful eyes of Bill Neill and Ed Block.

"We theorized," said Neill, the hospital's director of physical therapy, "that the physical medicine we used for outpatients here could also be used to prevent the Colts from suffering injuries."

Block, the Colts' trainer and an assistant to Neill in the off season, likes to refer to the equipment at Kernan as his "secret weapon."

"In analyzing the needs of each individual player we locate the stress and strain areas and with secret weapons we can strengthen those areas," Block said.

Block and Neill both point with pride at what their program has done for defensive end Ordell Braase. Said Neill, "he has increased his chest girth by more than an inch and his upper arm by half an inch."

"Block and I had Ordell act out what he does when rushing the passer. His actions, and where he needs strength, is what we've been working on."

"He will be much stronger and more agile this year."

Other Colts taking part in the program are backs Johnny Unitas, Lenny Moore, Lenny Lyles and L. G. Dupre and linemen Art Donovan, Jim Mutscheller, Dick Syzmanski, Leo Sanford and Gino Marchetti.

Where do the children fit into the picture?

"The Colts and the patients, mostly children, are good mental therapy for each other," said Neill.
