

Bids Received On Cave Work

Two bids were received in Thursday's bid opening at the National Park Service office, Federal Building, Medford, for construction of a residence, water and sewer system near Oregon Caves.

Tom Williams, park superintendent, said Southern Oregon Construction company of Grants Pass is apparent low bidder with a total bid of \$28,873. The other bid was received from B. D. Green of Ashland in the amount of \$34,185.

The work includes construction of a three-bedroom residence, installation of 1,300 feet of two-inch to four-inch water line, a 5,000-gallon tank, 1,000-gallon septic tank and disposal field. The project is located about a mile and a half below Oregon Caves.

The plans and specifications, as prepared by the National Park Service, San Francisco, included three alternates covering construction of a two-car garage with oil furnace and landscaping of the grounds. These three alternates amounted to \$10,637 in the Southern Oregon Construction Company bid which was deducted from the bid on the frame residence of \$27,109.50. The low bid includes \$11,119 for the water system and \$1,271.50 for the sewer system, Williams said.

He is married and has four children. The job of juvenile officer is on a part-time basis. Regular office hours will be established from 9:30 to 10:30 a.m., Mondays through Fridays.

Human Race Might Survive H-Bomb Warfare Effects

WASHINGTON (UPI)—A scientist gave assurance today that the human race would survive the hereditary damage of an H-bomb war between Russia and the United States.

It might even emerge—generations hence — "bigger, stronger, wiser, gentler, healthier." But the price would be enormous and the scientist, Dr. Robert R. Newell, earnestly advised against paying it.

He said the price would be "a large or major fraction of the population killed, or dying within a few months; survivors carrying many radiation-induced mutations; high infant and adult mortality for many generations."

Newell, of the Naval Radiological Defense Laboratory at San Francisco, testified before a congressional atomic energy subcommittee on the effects of protracted exposure to radiation in the aftermath of nuclear war.

Theory says that any amount of radiation, however low, can damage the genes—the reproductive cell units which transmit hereditary characteristics from generation to generation. It also says 90 to 99 per cent of changes, or mutations, wrought by radiation in the genes are harmful. The harm shows itself in such guises as defective children, stillbirths, low fertility.

In the hypothetical war between the United States and Russia, perhaps 40 million Americans of reproductive age would survive. Human beings have 20,000 to 100,000 new mutations to their children.

MURDER SUSPECT FREED

VIENNA (UPI)—An Austrian court has acquitted Johann Gassner, 30, in Austria's biggest past war murder trial. The eight-man jury split 4-4 Friday on whether Gassner was guilty or innocent of charges he raped and killed Viennese model Ilona Faber, 21, in a Vienna park in April, 1958.
