Talks Slated By Teamsters

SAN FRANCISCO (UPI) — San Francisco teamsters and their employers will return to the bargaining table today to try and settle the 11-day-old truck strike here.

Teamsters were turned down Saturday on their demand for a \$2.75 a day pay boost on a one-year contract. Originally, the Draymen's Assn. and California Trucking Assn., the representatives of trucking management, offered the drivers \$10 weekly pay raises each year for three years.

But teamsters argued they could get better economic security on a one-year contract.

Today's meeting was scheduled for 11 a.m. Union leaders and some operators were to attend. Union members reportedly were trying to line up separate contracts with owners willing to break the employers' united front.

Union spokesmen said that the picket situation was quiet, and that no more "rebel" pickets were roving the city to make unauthorized stops of trucks not involved in the strike as they were doing last week.

Picketing today is being done only at authorized locations, they said.

Water Users Must Observe Restrictions

YREKA — Violators of Yreka water regulations will be charged with a misdemeanor, according to Chief of Police Henry (Hank) Watson of Yreka, in an effort to enforce the current water rationing program prevailing in the town.

Water is scarce in Yreka, and the city officials are striving to conserve what water is on hand until the fall rains come. At present, the water regulations have been established so that each household is allowed two hours of irrigation on alternate days.

Citing the basic City Ordinance 75, Watson, said that violators of the water regulations will be charged with a misdemeanor, and shall upon conviction be penalized by a fine of not more than \$100, or by imprisonment in Yreka City jail, not exceeding 50 days, or by both fine and imprisonment.

Locker Plants To Support Junior Livestock Auction

YREKA—A junior livestock auction will be held Sunday, August 23, 6 p.m. at the Siskiyou County Fairgrounds, Yreka.

Four-H and FFA members have received support of certain locker plants to encourage purchases at the auction.

Five dollars will be donated toward cutting, wrapping, and freezing beef at Grigsby's Meat, Ober-

lin Road, Yreka; Siskiyou Distributors, Yreka; Weed Lockers; Jack's Meat at Goller's Greenview Store; and Scott Valley Lockers, Fort Jones.

The Pacific Packing Company will donate animal delivery. Charges for slaughter will be reduced to \$5 per beef, \$4 per hog, and \$1 per lamb.

Home Atchley of Cummings Drug, Yreka, will take orders for purchases. He will also take orders for a half-beef and pair-up a buyer for the other half.

If a buyer doesn't want the meat, the animal purchased may be consigned to the Pacific Packing Company. The meat will be resold.

The sales arena at the fairgrounds will have roofed bleachers, lights and a public address system.

San Francisco (UPI) — A congressional investigation into alleged Communist activities of some 40 local teachers was postponed today for the second time.

Inquires by the House Un-American Activities Committee will open here October 14. The original hearings were scheduled for June 17 and postponed until Sept. 1 so Rep. Francis E. Walter (D-Pa.), chairman of the committee and his staff could do more research.

Rock Marks Robbery Site

MOUNT SHASTA — Robber's Rock, beside the old stage road between Weed and Edgewood, marks a spot where a Wells-Fargo stagecoach was robbed one June day in 1876 by a man known as Black Bart. Whether or not the notorious Bart was the culprit will probably never be known. The man who was robbed believed Bart was the robber, but Bart, when captured, never named this as one of his many jobs.

The stage driver that day was John Sulloway, whose daughter, Mrs. Emma Thornton, lives in Mount Shasta. Sulloway stated the man carried a shotgun and wore a linen duster with a flour sack over his head and in every way conducted himself as Black Bart had always done.

Another Siskiyou County robbery was laid at Black Bart's door when a stage was robbed between Yreka and Hornbrook. A marker has been erected there naming Bart as the robber. It may also be a case of mistaken identity, Bart never confessed to being that far north.

One wanting to see the old marker for the Weed robbery can do so by leaving U.S. Highway 99 a mile north of Weed, going past the golf course, and traveling about three miles toward Edgewood. A big sandstone on the right of the dirt road was the screen behind which the highwayman stood while waiting for the stage. A small trout stream is on the other side of the road.

Today it is a peaceful scene that would seem an unlikely place for violence to have been enacted. But in 1876, it was different.
