FCC Approves Sale Of KFJJ

The Federal Communications Commission this week granted the transfer of Radio Station KFJJ from the W. D. Miller Estate to Gibson Radio, Inc. The new owners are Riley R. Gibson, president and general manager, and three California partners. Gibson has been in radio for 20 years, and is also president of the corporation which owns Radio Station KXOA in Sacramento.

The Gibsons moved here from El Centro, California, after selling Radio Station KXO in that city, where Gibson had been manager for nine years. Gibson is immediate past president of the El Centro Chamber of Commerce, and was serving on the City Planning Commission and Rotary Board.

He is also past president of United Fund and Salvation Army in El Centro.

District Sets Budget Meet

A public meeting to discuss the 1960 proposed budget and program for the year has been set by directors of the Tulelake Irrigation District for Monday, October 26, at the district offices.

Proposed water rates for 1960 is at the same rate as in 1959 on the private lands with a reduction to \$7.20 per acre in the public lands.

Proposed replacement work in the private land areas would be continued at the same rate as in 1959. A tentative 10 year replacement program was submitted for consideration of which major items in addition to the check and T. O. program was work on pumping plants and wooden flumes.

NEW YORK (AP)—Several million people, mostly in the Northeast, get an extra hour Sunday—marking the end of daylight saving time.

A number of areas on daylight saving time made the switch a month ago. But in Kentucky it will last until Oct. 31 except in Lexington and Frankfort; they have daylight saving time the year 'round.

OTI, SOC Students Bang Heads In Bonfire Brawl

OTI and Southern Oregon College students tangled Thursday night in a scrap that began as an innocent expression of campus rivalry but developed into a head-breaking, car-smashing brawl.

SOC officials revealed Saturday that three students were hospitalized and that others were treated at doctor's offices after the six-hour battle in and near Ashland.

A report that one SOC student was hospitalized with a compound jaw fracture was unconfirmed, but one student said a combatant from each school was hospitalized with vicious head wounds and that others were treated after being swatted in the back by heavy boots.

"One of some 50 or 60 OTI students who drove to Ashland said the evening's entertainment resulted in the total wreckage of three SOC student cars, hand-to-hand combat with chains, pipe lengths and two-by-four boards, and aerial combat with rocks.

The student said one SOC supporter had a rifle and that he heard two shots during the night.

It was reported from SOC that an OTI man appeared with a 30-30 rifle, but this was denied here. The fracas began about 9 o'clock Thursday night when the first group of OTI students drove to Ashland. Another contingent arrived about midnight, a student said, and the first bunch was pretty much in trouble by the time they got there.

A bonfire, to have been set afire Friday night, was the target of the night. "The whole thing was a friendly 'doo,'" an OTI student said. "We were going to burn their bonfire for them."

He said the first contingent—nine carloads of OTI students made the trip before the night was out — got into town and burned an "O" on the SOC football field. It was on that field that OTI beat SOC 14-6 last weekend to tighten its Oregon College Conference lead.

Then the OTI bunch headed for the woodpile that was to become SOC's homecoming bonfire. "It was more or less something to do," the student said. "We thought we'd burn it for them a day early."

SOC students caught the invaders downtown and first tried to force them out.

Mount Shasta Fires Persist Despite Arrest Of One Man

MOUNT SHASTA — Leland G. Graham, former Mount Shasta Post-Office employee who was apprehended by police Tuesday night and charged with arson, was adjudged mentally unsound at a hearing held Friday morning.

Graham will be committed to an institution for treatment. However, authorities admitted that Graham's apprehension did not halt the fires which have hit Mount Shasta and vicinity during the past week.

Most of Mount Shasta stayed up until midnight Friday, but no late evening fire developed. A grass fire was reported at 6:30 p.m. but was extinguished quickly.

The outbreak of fires began Monday, October 19, when an abandoned schoolhouse at Azalea, between Dunsuir and Mount Shasta, was burned. It contained antiques and furniture belonging to the T. Hunter family.

Six other fires followed in the next four days, all apparently set, and all discovered about 11 p.m. An empty building in Shasta Retreat, near Dunsuir, burned also on Monday night. A hay barn near here and an empty home about five miles northwest of here were burned on successive nights. Thursday night, an unoccupied residence one and one-half miles south was destroyed, bringing the total of blazes to seven.

Authorities indicated that two of these fires have occurred after Graham had been jailed on suspicion of arson.

A citizen's committee has set up a night patrol for unoccupied residences and buildings, and residents have been warned to stay away from such buildings.
