Stern Enforcement Set For Television Industry

WASHINGTON (AP)—The new year prospect for the multi-billion dollar broadcasting industry today was a dose of federal law against such things as payola and quiz rigging.

A sterner enforcement of present laws and regulations appeared on an even more immediate probability.

A day after President Eisenhower made public a special report he had asked from Atty. Gen. William P. Rogers, most discussion was not about whether laws against fakery are needed, but how sweeping they should be.

In general, Rogers recommended some additional law but principally more vigorous enforcement by the Federal Communications and Federal Trade Commissions.

Several congressmen who have played prominent parts in last year's investigations said, however, they are ready now to go well beyond Rogers' recommendations.

Then, without advocating them, the attorney general suggested two other possible changes that might be considered later.

Putting networks themselves under federal regulation, as individual stations now are.

Broadening the power of the Federal Trade Commission to move against false advertising or deceptive trade practices in any area of the economy. Its authority to seek injunctions is limited now to food, drugs, therapeutic devices and cosmetics.

Nevertheless, Rogers told the commissions concerned with broadcasting "appear to have authority adequate under existing law to eradicate most, if not all, of the deceptive and corrupt practices in broadcasting which have been disclosed."

However, Rogers noted, the government's enforcement weapons "do not appear to have been used as effectively as they can be."

Both the FTC and the FCC have taken a new look at their responsibilities since the irregularities were brought to public attention last year by the House subcommittee on Legislative Oversight.

There was no immediate comment from the broadcasting industry on Rogers' recommendations. Members of the Communications Commission declined comment until they could study Rogers' report.

Chairman Earl W. Kintner of the Trade Commission said he was pleased with the report of criminal trespass, but was acquiescent on appeal to the circuit court. The Multnomah County Circuit Court granted Kintner the \$80,000 in a jury trial. But the Supreme Court reversed it because of errors made in that trial.

High Court Of Oregon Sets Record

SALEM (AP)—The Oregon Supreme Court finished its year Thursday by establishing a modern record for handing down decisions in a single year.

Justice Sereno, court clerk, said the court rendered 242 opinions, involving 264 cases, during 1959. That is the largest number in many years, he said.

The 1958 total was 178 opinions. The court, trying to catch up with its backlog, was given an assist by the 1959 Legislature. It allowed the court to name two temporary justices to serve along with the seven regular justices.

Sereno said the increase over the 1958 figure is about the same as the number of opinions written by the temporary justices. The court handed down five opinions Thursday.

It reversed a \$60,000 false arrest judgment that Anton Kraft had won awarded in Multnomah County against Montgomery Ward & Co.

Kraft was arrested on a charge of burglarizing a Ward store, but was convicted in municipal court of criminal trespass, but was acquitted on appeal to the circuit court. The Multnomah County Circuit Court granted Kraft the \$60,000 in a jury trial. But the Supreme Court reversed it because of errors made in that trial.

Each county may send only one 4-H girl and boy as delegates to the Oregon conference. Interested and eligible 4-H club members from Klamath County must submit their permanent record with 1959 and 1958 stories to the 4-H club office by January 10 to be considered.

To be eligible, each delegate must have completed at least three years of 4-H club work and be currently enrolled in 4-H. The delegate also must have been 12 years old before January 1, 1959, and preferably at least a junior in high school. The delegate, if in high school, must be in the upper third of the class. In college, the delegate must have a grade point equal to or above the student body average for the institution the delegate is attending.
