Fifth grade Troop 47 of Peterson School and leader Mrs. Charles Johnston donated food and other gifts to a needy family recently.

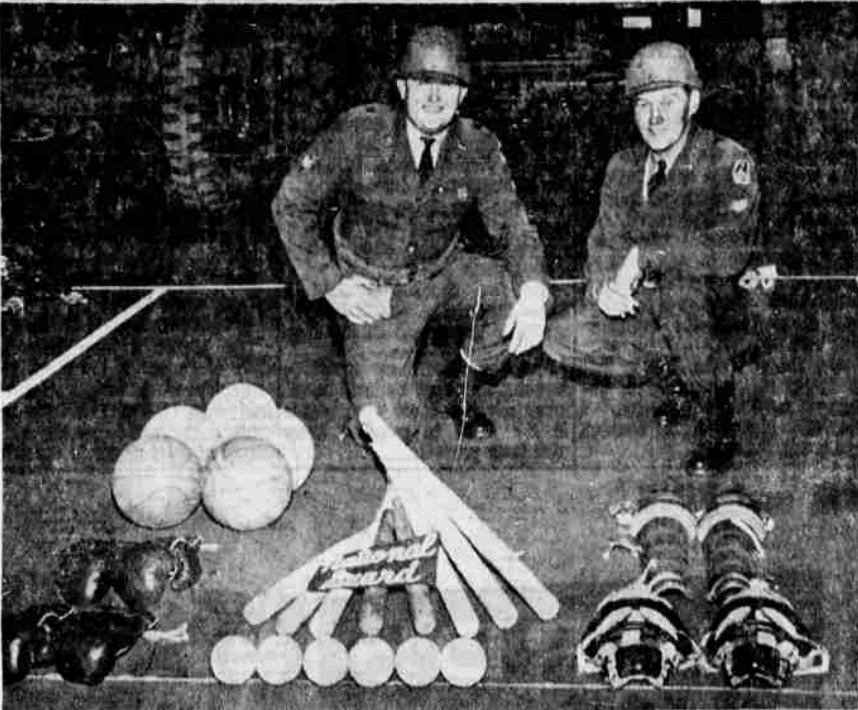
BETTER LATE THAN...

Despite the near-zero temperatures and the scanty mantle of white, the tourism industry in Klamath County remains active.

One print of the chamber's TV film, "Wish You Were Here," was shipped off to Milwaukee a week ago. Another print went south to the greater Los Angeles area...

Another point is well illustrated here, and that is that chamber effort is the result of the voluntary contribution of ideas, energies, service and funds on the part of its many members. Chessman Involved In Spat With Five Other Prisoners

SAN QUENTIN, Calif. (UPI)—A wild fight involving convict-author Caryl Chessman and five other prisoners broke out Friday when the inmates in San Quentin's "death row" were led into their exercise area to watch the bowl games on television.

The 15-minute free-for-all was the first of two fights here Friday. The other, involving two prisoners, sent one convict to the hospital with face cuts requiring 30 stitches.

Associate warden Louis Nelson said Chessman, sentenced to die in San Quentin's gas chamber Feb. 19, leaped into a fight between Jim Merkouris, 43, and Manuel Chavez, 27. He said Chess-

man joined the fray on the side of Chavez.

"The others evidently saw this as a chance to get their licks in, too," Nelson said.

The other convicts involved were Clyde Bates, 39; Marion Linden, 45; and Donald L. Cash, 32.

dashed it to the floor. Merkouris suffered the only injuries, a bloody nose and bruises.

Nelson said he would question participants in the brawl Monday before he decides on disciplinary action. He described Merkouris as a "loner" with whom the other prisoners don't associate.

The other fight, which occurred a few hours after the first brawl, broke out during the prison's New Year's Day show in the dining room. Nelson said Jessie Penalver, 33, was slashed about the

face by Jesus Cervantes, 27. He said Cervantes seized a drinking glass from Penalver, broke it and attacked him with the jagged edge.

Cervantes was placed in isolation.

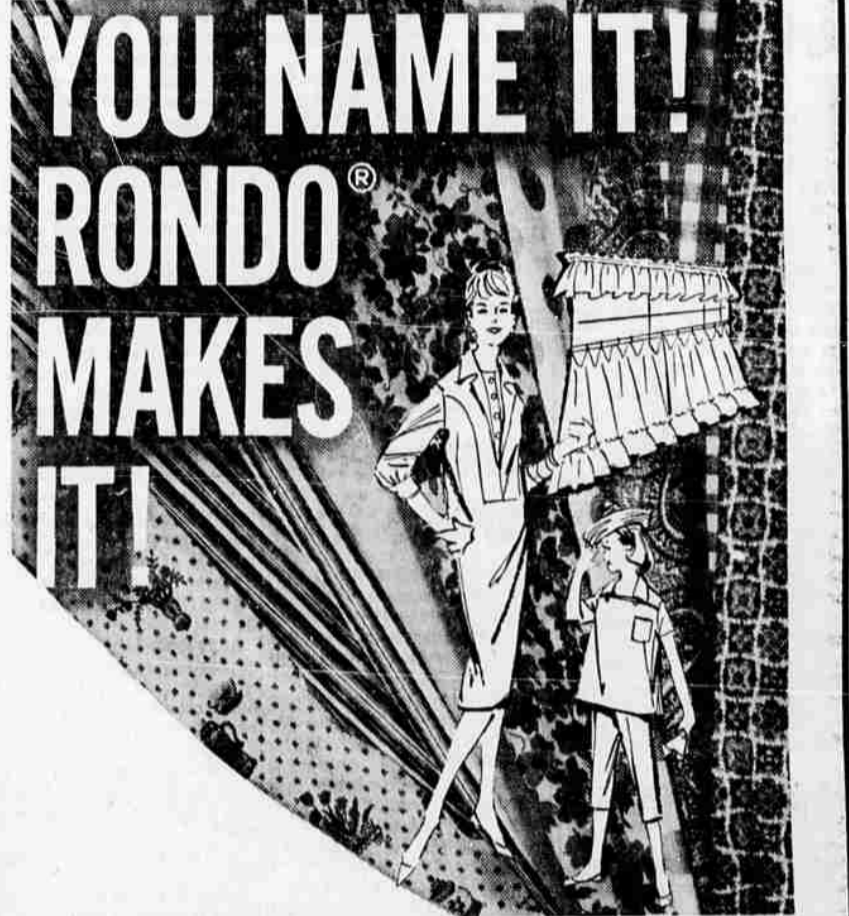

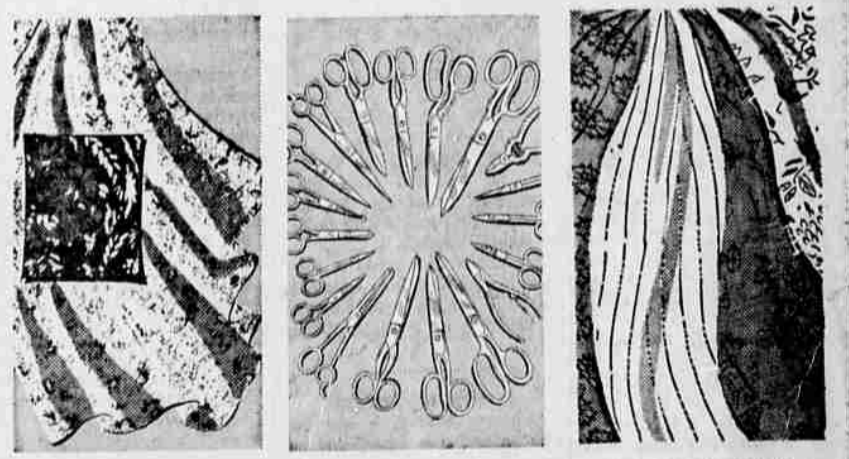
