

### Idaho Skiers Earn Chance

TOLLGATE, Ore. (AP) — Two Idaho skiers Sunday won the combined titles at the Pacific Northwest Ski Assn. junior championships at Spout Springs.

The championships qualified Bob Jonas and Sandra Shellworth, both of Boise, for the national junior championships at Aspen, Colo., in March.

Miss Shellworth placed second in Saturday's slalom and then clinched the combined title by winning the downhill Sunday in 38.2 seconds.

Jonas had a second-place finish in the downhill — 35.4 seconds — but that, combined with his second in the slalom, gave him enough points for the combined title.

The downhill was won by still a third Boise skier, Jim Redfield, who whizzed down the course in 34.4 seconds. Third was Terry Foley of Spokane in 35.6.

Susan Cutler of Bend was second to Miss Shellworth in the girl's downhill. Her time was 38.8 seconds. Kay Eyraud of Walla Walla was third at 39.6.

### Thomas May Try Decathlon

BOSTON (AP) — John Thomas may not know it, but there's a chance he's being prepared for competition in the decathlon.

"You see, he's a dog for work," Boston University Coach Ed Flanagan said of his young high jump champion. "No matter what kind of a program I lay out for him he wants more work."

"So I've had him working on field events other than the high jump, everything but the pole vault. Just to take his mind off the high jump. He's done 44 foot 10 inches in the 16-pound shot, 100 feet in the javelin and has broad-jumped 23 feet 6 inches."

Thomas' mastery in the high jump is unchallenged. The 18-year-old Boston University student holds the world record at 7 feet 1 1/2 inches, set last season when he was 17.

Saturday he made his first competitive appearance in nine months, taking the high jump in the Knights of Columbus Games with a leap of 7 feet 1/2 inch. It was his first public appearance since a foot injury sidelined him and threatened his career.

He failed in three attempts at a new record mark, 7 feet 2 1/4 inches, Saturday.

### Paul Valenti Credits USC, 'Tough Club'

CORVALLIS, Ore. (AP) — A week ago, when Oregon State's basketball team began a month of games on the road, the Staters had a 9-2 record.

And now, two games later, the Staters own a 9-4 mark, the latest addition to the loss column an 84-59 defeat at the hands of Southern California in Los Angeles Saturday night.

"Give credit to Southern California. They took care of us in good style," OSC interim head coach Paul Valenti said after the Staters returned here Sunday night.

Southern California, he said has outstanding personnel. "They had a good evening against us. It's a tough team."

Southern California, the only team to beat California's defending national champions this season, now is 11-5 for the season.

Against the Staters, Southern California used mostly sophomores, and didn't even send its sharpshooter, John Werhas, into the game. USC got a big early lead and kept it. Bill Woid topped the Staters with 29, and Jay Carthy added 18.

"We've got the same problem we've had all along," Valenti said. "We must strengthen our offense some. We've got to find that take-charge boy who can go in and get a couple of baskets for us when we need them."

Valenti said there sometimes is a tendency to work either too hard on offense or too hard on defense in the team's drills.

"When you don't get in both, you hurt both ways," Valenti said, however, drills will be on the light side this week — and next — for the Staters play away from home the rest of the month.

It takes a lot out of a team to spend several weeks playing on the road, the coach said, and added: "It's going to be very important we don't work the kids too hard."

The Staters will leave for the north Thursday, and will play at Washington State Friday night and at Idaho Saturday night.

Valenti said the team has missed coach Slats Gill, hospitalized in Seattle since suffering a heart attack a week ago.

"It's affected the kids some," Valenti said. "It's affected me, too."
