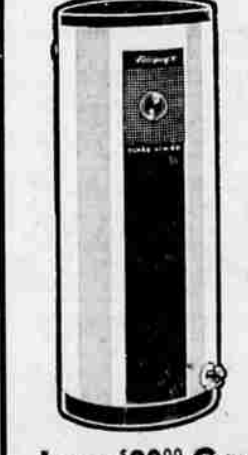

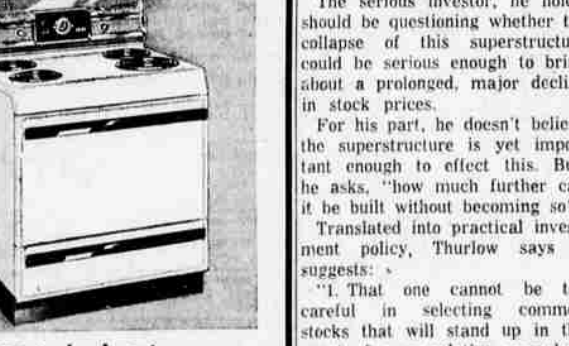

Thurlow also noted the lack of sufficient stock supply helped the rise. This was caused by double taxation of dividends and corporate tax exemption of bond interest which virtually forced corporations to raise money by selling bonds rather than stocks, and capital gains taxes deterring long-term holders of good quality issues from selling. "Many investors," says Thurlow, "literally prefer to die rather than pay capital gains taxes to the government."
