Cal Plans New Boxing Assoc.

SACRAMENTO, Calif. (UPI)—California today took the initiative towards forming a rival for the National Boxing Association by inviting New York and 11 other states to a Los Angeles meeting on the subject next week.

The other states invited were Washington, Oregon, Nevada, Arizona, Utah, Colorado, Idaho, Montana, New Mexico, Hawaii and Alaska.

Dan O. Kilroy, president of the State Boxing Commission, which pulled out of the NBA last month, said the 13 state commissions, if they don't form a new association, might agree on a working agreement to police boxing.

"This is the last chance for the states to clean their own house," Kilroy said. "If they don't do something, we'll have the federal government running things."

California, New York and Massachusetts have withdrawn from the NBA. Kilroy said he hoped the Western states invited to the meeting would decide to withdraw also. He said Massachusetts was not invited because that state has "not shown the zeal" to clean up boxing.
