Debates Set Tonight By Oregon Candidates By THE ASSOCIATED PRESS Candidates for five major Oregon offices in the November general election will debate on the same platform tonight in Portland. The debates, which have become an integral part of the current campaign, will be held at 7 p.m. The debate between Elmo Smith and Maurice Neuberger, candidates for U.S. Senator, will be carried tonight at 10 p.m. on KOTV-TV from Lloyd's Center in Portland. candidates' fair sponsored by the League of Women Voters at the Lloyd Center. Here is the lineup of the races, candidates and debate topics: U. S. Senate—Democrat Maurice Neuberger and Republican Elmo Smith, medical care for the aged. Attorney General — Democrat Robert Y. Thornton and Republican Carl Francis, the role of the attorney general. State Treasurer — Democrat Ward Cook and Republican Howard Belton, whether the Board of Control should be abolished. Secretary of State—Democrat Monroe Sweetland and Republican Howell Appling Jr., whether Oregon should require a literacy test as a requirement for voting. 3rd District Congress—Democrat Edith Green and Republican Wallace Lee, whether Congress should authorize federal aid for teachers' salaries and school construction. Mrs. Neuberger and Smith met in debate once again Tuesday night over Radio Station KEX in Portland. Smith was asked for his views on defense spending. "We must stay ahead and I'll support any kind of program that keeps us ahead," he said, and added that this nation was not behind Russia. Mrs. Neuberger then quoted Alen Dulles, chief of the Central Intelligence Agency, as saying that Russia now is far ahead of the United States in missiles and space development. Other candidates also campaigned in Portland Tuesday. Appling, the incumbent secretary of state, said he disclaimed any part in a letter he said was aimed at discrediting Sweetland, his Democratic opponent. Appling said he also was the object of a whispering campaign, and added: "While we disagree on many issues, I am certain that Mr. Sweetland would join me in deploring such tactics as our respective political enemies are now apparently resorting to." Democrats, meanwhile, said they were seeking funds to permit Sweetland to appear on radio and television to answer what they termed was a vicious smear. In another appearance at Portland, Appling said he proposed an end to duplication in delivery of the Voters' Pamphlet. "Every voter in every household gets a copy," he said. Needless duplication costs the state about \$60,000 each election year, he said. State Sen. Robert Straub of Eugene, the Democratic state chairman, Tuesday issued the last of a series of his reports on Smith, and said Smith's record in the state legislature was one of "obstruction and of favoritism to special interests." Straub said Smith, as a state senator, opposed civil rights measures, opposed creation of Portland State College and sponsored legislation to destroy referendum power of the people against unfair tax laws. "No other Oregon legislator in recent times, Republican or Democrat, has compiled such a record of reaction, backwardness and isolation," Straub said. At Pendleton Tuesday night, Ron Phair, the Republican candidate for Congress in the 2nd District, said Rep. Al Ullman, the Democratic incumbent, had jeopardized a bill authorizing the Navy to swap the Boardman Bombing Range for state-owned land in Lake County. Conceit Hit By Phair ONTARIO—Ron Phair, Republican candidate for Congress from the Second District, said today before a chamber of commerce meeting that he was "astounded" over opponent Rep. Al Ullman's conceit and audacity in believing that he had chalked up such an excellent record in Congress that Phair or anyone else should not have opposed him for reelection. Phair referred to an editorial in the September 1 edition of a Baker weekly newspaper, The Record-Courier, that stated, "Al Ullman for all his capacity in getting the job done for his district and for his general sound and intelligent application to national and world problems that come up before the Congress would normally have no opposition for reelection." Phair pointed out that Ullman had had the editorial reprinted and was handing it out as campaign literature. "My opponent obviously agrees with the editorial," Phair said, "and it is inconceivable to me that anyone would publicly state that he had reached such a degree of perfection that no one should dare to oppose him, even if he thought so privately." "I never realized that some people considered Mr. Ullman an 'untouchable' and that I would be scorned for doing so," Phair said. "But of course the Democratic camp has also ridiculed me and my volunteer campaign workers for our 'inexperience' in politics," he added. Phair said that he would rather have "ardent amateurs" as his workers than "political hacks." "I have no hardened politicians on my staff, only one paid campaign manager and one part-time paid office manager, neither of whom is 30 years old yet. I wonder how many COPE field workers Mr. Ullman has coercing voters into voting for him," Phair asked. "My opponent has voted for practically all bills that would add to the growth of the federal government, increase our taxes, and reduce our freedom. He shouts out in favor of the little farmer, and then turns around and votes for the big corporation farm. Our present congressman refuses to explain his views on Red China. He votes against labor reform legislation," Phair said, adding, "and then he wonders why he is opposed for reelection. Well, I'll tell you, it's because we Eastern Oregonians need genuine representation for everybody. We, in this part of the country, just don't think the way Mr. Ullman does."
