Mobutu Troops Fire On U. N. Congo Force

Washington Election Facing Recount Move

SEATTLE (AP) — The tight election battle in Washington's 7th Congressional District was dumped into the lap of a board of two Democrats and one Republican Tuesday.

The King County Election Board scheduled a meeting to consider a request from the County Republican Central Committee for a recount of the votes.

County Auditor Robert Morris, who announced Sunday that Democratic Rep. Don Magnuson had won re-election by 116 votes, said he would recommend the recount.

Morris is a Democrat. The board's other Democratic member, Chairman Howard Odell of the Board of County Commissioners, and the Republican member, Pros. Atty. Charles O. Carroll, indicated they would concur.

Magnuson trailed Republican John Stender, a Seattle labor union official, by 338 votes in the unofficial Nov. 8 election count and by 666 votes after absentee ballots were counted. Morris said Stender's lead was overturned by the discovery of errors in the unofficial tabulation.

John R. Barnard, county GOP chairman, told Morris in a letter Monday that the GOP committee felt a recount should be conducted "as a step in preserving the confidence of the voters in our election system."

"We do not in any way question your integrity," Barnard said. He added: "We believe there can be no question in the recanvass because, as we understand it, the count is correct."

Cubans Hurt 19 Students

HAVANA (UPI) — Travelers from central Cuba today reported increasing anti-government sabotage in Camaguey Province. They said two trains were derailed and the provincial capital's power plant was bombed last week.

At the same time, it was reported rifle-swinging Castroite "multitudines" sent to break up a Roman Catholic student strike wounded 19 young Catholics who were mourning the execution of a classmate.

The students held a mass meeting in Camaguey last week in memory of Porfirio Lambert Ramirez, president of Central University's student body, who was shot last month as a foe of the government.

Speakers at the meeting were bitterly critical of the revolutionary regime.

"Cuba is the biggest country in the world!" one speaker shouted. "Its capital is in Havana, its government is in Moscow and its people are in the United States!"

Oregon Fir Selected For Honor

EUGENE (AP) — There was no traditional cry of "Timber" when loggers felled a 98-foot-high Christmas tree for the White House Monday.

Instead two mechanical cranes stood by to lower the Douglas fir gently. It did not even touch the ground, but went directly onto a logging truck.

Cut in a forest east of here, the tree was taken to nearby Springfield, where it now is being washed. Its branches will be wrapped in burlap, its butt in wet peat moss, then in plastic to preserve its freshness when it leaves by rail Friday for Washington, D. C.

U.S. To Pull Naval Patrol

WASHINGTON (UPI) — The United States probably will begin withdrawing its naval patrol off Guatemala and Nicaragua within a week or so unless new violence erupts in the area, an administration source said today.

This source said no "firm decision" to recall the patrol had been made but that President Eisenhower was expected to review the possibility within the next few days.

The State Department was understood to feel that the United States would appear in a bad light if it kept the patrol in operation indefinitely.

Eisenhower announced last Thursday that a U. S. Navy force including the carrier Shangri-La, five destroyers and two radar planes was in position to "seek out and prevent intervention" against Nicaragua or Guatemala from "Communist-directed elements," meaning Cuba.

EXILED CHIEF DIES

GENEVA (AP) — Gen. Phao Sriyanond, exiled former police chief of Thailand, died of a heart attack in his Geneva apartment Monday.

Western delegates predicted he would win by a comfortable margin, but the issue was complicated by fighting in Leopoldville Monday night between U. N. troops and the forces of the Congolese army chief, Joseph Mobutu.

Kasavubu in a statement defended the action of Mobutu's army in using force in an effort to throw out a Ghanaian diplomat who has been acting as advisor to Patrice Lumumba, Kasavubu's rival.

The assembly resumes debate after a late night session in which

several delegates pushed Kasavubu's candidacy.

Cuba's ambassador, Manuel Bissbe, led off the debate with a heated attack on "anti-African colonial leaders" and a blast at Kasavubu and his associates as tools of the imperialists.

Opponents of the move to action should be taken until the U. N. conciliation commission goes to the Congo to try to bring warring political factions together.

Guinea announced earlier that President Sekou Toure had sent a cable to President Eisenhower charging the United States with taking a partisan stand in behalf of Kasavubu in assembly debate and declaring that Guinea would refuse to take part in the conciliation mission if the United States sticks to its position.

The Soviet Union put out a statement accusing the U. N. Command of collaborating with Mobutu. It called for an immediate report from Secretary-General Dag Hammarskjold on the latest turn of events in the Congo.

The Soviet charge apparently was triggered by word from Leopoldville that Mobutu's army attacked the residence of Nathaniel Welbeck, Ghana's charge d'affaires in the Congo, and that the United Nations had yielded and agreed to hand Welbeck over to the Congolese for expulsion.

Earlier the United States accused the Soviet Union of trying to plunge the assembly into a cold war debate on an issue that should involve Africa alone.

In other Congo developments: Hammarskjold warned that the United Nations must put up the money needed to pay for its 20,000-man army and other activities in the Congo or junk the entire operation.

Hammarskjold told the 99-nation U. N. financial committee that the world organization was faced by a grave financial situation that threatened not only its Congo command but all its other operations. He said the U. N. treasury would be virtually bare by the year's end.

Ghana Diplomat Forced Out Of Congo

The U. N. hurriedly reinforced the guard around the building and set up machine gun positions for defense. Mobutu urged his men at Binza Camp, five miles outside town, to remain calm.

Nathaniel Welbeck, personal representative of Ghanaian President Kwame Nkrumah, left his bullet-riddled embassy at dawn and was escorted to Leopoldville's M'Pili Airport for a flight to Accra.

Plane Flight Delayed The plane was held up for more than an hour while Mobutu insisted that Richard Quashie, sent to replace Welbeck Monday, also leave. Quashie finally boarded the plane and it left for Accra.

In the 12-hour battle, reports said four Congolese—including Col. Joseph Nkoko, commander of the Congo army's Leopoldville garrison and Mobutu's second in command—were killed. The unconfirmed reports also said that

three Tunisians were killed with about 10 men on each side wounded.

The Congolese press agency said later that Nkoko's death was confirmed by official sources. The agency added that two Congolese soldiers died in a hospital of their injuries. Congolese soldiers said Nkoko was the first man to be killed Monday night.

Mobutu dispatched a force of about 200 troops, backed by armored cars, when Welbeck defied an order to get out by 4 p.m. Monday. The embassy was guarded by some 200 Tunisian U. N. troops. Another force of 600 Tunisian soldiers moved up behind the Congolese.

The Congolese troops opened fire with 20-mm cannon from the armored cars, rifles and machine-guns. Bursts of bullets occasionally sprayed the surrounding streets, forcing passersby and newsmen to dive for cover.

The shooting lasted until after midnight. Trigger-quick Congolese troops maintained a tight cordon around the Ghanaian diplomatic residence through the night, firing at anything that moved. Several cars, including those of reporters, were fired on but there were no reports of casualties.

At intervals, the Tunisians fired red flares which cast an eerie light over the area.

In New York, Kasavubu's foreign minister, Justin Bombolo, said the major responsibility must be borne by President Kwame Nkrumah of Ghana. He said Nkrumah was informed more than a month ago that the diplomats were unwelcome but wrote a letter to Kasavubu "defying" the expulsion order.

Several delegates pushed Kasavubu's candidacy.

Cuba's ambassador, Manuel Bissbe, led off the debate with a heated attack on "anti-African colonial leaders" and a blast at Kasavubu and his associates as tools of the imperialists.

Opponents of the move to action should be taken until the U. N. conciliation commission goes to the Congo to try to bring warring political factions together.
