Seven New Agencies Suggested

SALEM (AP) — Gov. Mark O. Hatfield today called for sweeping state government reorganization that would greatly increase his authority through a cabinet form of administration.

Hatfield's proposals, to be submitted to the Legislature next month, would create eight major departments—Social Services, Education, Labor, Commerce, Transportation and Utilities, Public Safety, Natural Resources, and Revenue.

The governor would name the department heads, with consent of the Senate. In most cases, the department heads would name the division heads under them, with consent of the governor.

Hatfield said his program would coordinate activities, strengthen planning, and permit "the governor to serve as the state's chief executive in fact as well as in name."

Old Car Is Clue In Kidnaping Case

SULTAN, Wash. (AP)—A cheap, well-worn car, sold by a dealer only four days ago, and a scrawled note were the principal leads Thursday in a botched \$25,000 kidnap plot involving a banker's daughter.

Spunky, blonde 17-year-old Hazel Irene Oelrich was the center of attention in this little western Washington logging community as officers worked to unravel the bizarre, day-old case.

Hazel, a high school senior, described her 90-minute abduction by a middle-aged, seedy looking man as "much more fun than going to school."

She remained far more self-possessed than her family. Her father, George Oelrich, is manager of the Sultan branch of the First National Bank of Everett.

The many fantastic aspects of the case led authorities to believe the ransom scheme was the brainchild of an incredibly inept, bungling, stupid and desperate man.

Supporting the girl's story were these facts: Oelrich received a telephone call Wednesday morning from Monroe in which a man demanded \$25,000 for his daughter's release, and she tearfully told her father in the same conversation she had been kidnapped while leaving for school. Monroe is seven miles west of here.

Whether this was a spur-of-the-moment kidnaping or a pre-conceived plan puzzled county and federal officers. The fact the man let the girl go in Monroe before trying to pick up the ransom money at a service station telephone booth there appeared to indicate it was the work of an amateur.

The Oelrich girl was alone at home when the man appeared. Her parents had left a short time earlier for the bank, where both work.
