

# 1924 Thrill Slayer Now Wants To Marry, Teach

SPRINGFIELD, Ill. (AP)—Nathan Leopold, sentenced to life plus 99 years in prison for a 1924 "thrill slaying" that stunned the nation, has asked that his parole period be cut to permit him to marry and to become a teacher. Leopold served 33 years before his sentence was commuted. He was given a five-year parole term when released from Stateville Prison, Joliet, in March 1958. Charles F. Kinney, chairman of the Illinois Parole and Pardon Board, said Leopold and his attorney, Elmer Gertz of Chicago, as well as several persons in Puerto Rico, have asked the board to reduce the parole period to three years. Leopold was paroled to work as a hospital technician in Puerto Rico and subsequently undertook graduate study in social work at the University of Puerto Rico. Should the request be granted, his parole would end in March. Kinney said Leopold wants to become a medical social worker and also to teach at the University of Puerto Rico. Under Puerto Rican law, a parolee can do neither. Leopold also wants to marry a widow in Puerto Rico. Kinney said. As a parolee, he could obtain permission to wed from Illinois authorities, but the request was included with the plea for a shortened parole period. Kinney said the board may express an opinion on Leopold's request when it meets next week and may set a date for a formal hearing. Leopold and Richard Loeb, gifted children of wealthy Chicagoans, were convicted of the slaying of young Bobby Franks. Loeb was killed in prison by another inmate.

# Wife Has Second Chance, Decides Against Hubby

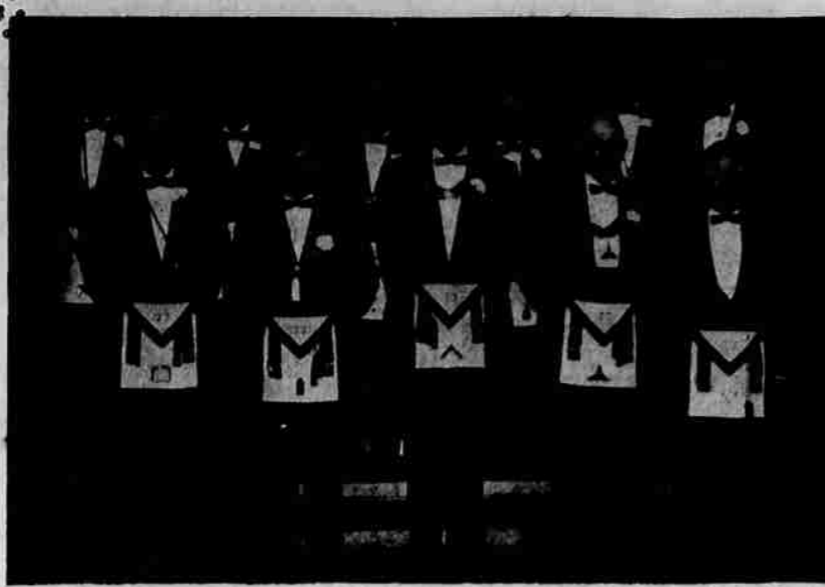
LONDON (UPI)—Clifford and Joan Chambers always felt they were an average married couple. For 16 years they lived together. They had five children and the usual number of quarrels, laughs, tears, joys and heartaches. Neither thought about what the choice would be if they had it to do all over again—until they got that chance. After a prolonged argument, Mrs. Chambers went to court. An investigation showed Mrs. Chambers was only 15—below the age of consent—when she wed Chambers in 1944 and the court annulled the marriage. Clifford tried to make up with his wife and proposed to her a second time. She said no. Mrs. Chambers said the more she thought about her married life, the madder she got. She said the only things she could recall were the "fights, big and small," that she had with her husband during their marriage. Then she realized something else. "In 16 years of married life, I never once had a vacation," she told the court Tuesday. Her husband began to get worried and told her, "let's get married again right away." But Mrs. Chambers shook her head and said her mind was made up. "I am tired of it all," she said. "I want to rest. If we got married again, it would be more of the same thing." Tuesday night, Mrs. Chambers and her husband slept in separate beds in separate rooms of their home in Derbyshire.

SALEM (AP)—A newspaper typographical error caused Senate President Harry Boivin, D-Klamath Falls, to take a ribbing. The news story said that when Boivin was speaker of the House at the 1937 session, he served 10 years, instead of days, as governor. Sen. Walter J. Pearson, D-Portland, who just completed his two years as Senate president, said he thought he had the record for being acting governor. He was referring to Gov. Mark O. Hatfield's absences from the state. Then Sen. Thomas R. Mahoney, D-Portland, quipped that it probably seemed like 10 years to the people. Boivin answered that the newspaper probably got mixed up as to just where he did serve the 10 years.

# Economic Issues Have Many Facets Kennedy Must Watch

Editor's Note — President-elect John F. Kennedy faces two major economic problems as he prepares for his inauguration next week. One is a recession at home. The other is continuing flow of U.S. gold abroad. Here's a report on his likely approach toward the two big economic issues, second in a five-part series on plans and problems of the new administration. It is written by an Associated Press reporter who specializes in business and economics news beats in the nation's capital.

WASHINGTON (AP)—As a presidential candidate, John F. Kennedy urged a faster-growing economy. As the president, his first problem will be to make it grow. The economy hasn't been growing at all since mid-1960. It has slipped into its fourth recession since World War II and most forecasters see little hope of an upturn before spring or summer. Determined to hurry the recovery, Kennedy is expected to unveil an antirecession program soon after he is inaugurated on Jan. 20. Even as he does so, however, Kennedy will keep one eye cocked over his shoulder at the second major economic problem he will inherit—the whopping deficits in the U.S. balance of international payments.

The President-elect made this clear during the campaign by repeatedly arguing there can be no strength abroad without strength at home. Indeed, Kennedy contends the image of a vital, expanding America would do much to dispel nagging foreign fears about the dollar. Even so, he won't be able to let the gold problem slide, particularly since his antirecession measures will tend to raise new questions about the gold situation. Eisenhower has attacked the payments deficit by curbing federal spending abroad, calling for reducing the number of military dependents overseas, promoting exports, and urging more help from other nations in financing the free world's defenses and development.

Kennedy may make some modifications but won't undo the whole package unless there is a significant reduction in the gold drain. Since foreigners bought more than \$770 million of U.S. gold last month, that reduction is yet to come.

Finally, even as he worries about gold and the recession, Kennedy will be pushing for a long-term economic growth program and an attack on the persistent unemployment problem.

In one of the sharpest shifts of policy direction in the economic field, the Eisenhower administration's preoccupation with fighting inflation is expected to be subordinated to new emphasis on full employment and economic expansion.

# Defendants Win In Court

LAKEVIEW — The decision of the court was in favor of the defendants in a suit in equity heard before Circuit Judge Charles H. Foster here last week. The defendants were given cost disbursements. The plaintiff was Warner Valley Stock Company which asked for specific performance of an agreement with B. C. and Goldia Robinson. The case, which was closed Friday evening, involved an agreement of June 1, 1945, between the Robinsons and William Kittredge and Son granting the latter an option on Big Valley lands owned by the Robinsons as a site for a reservoir and dam to be constructed within a 10-year period, ending June 1, 1955. In its decision the court found that B. C. and Goldia Robinson had granted to William Kittredge and Son a "license" for a period of 10 years to build a reservoir at Big Valley and that as a license it was revocable at any time, and that it was terminated in this case by one of two reasons: 1. Attempted assignment by Kittredge and Son to the Warner Valley Stock Company. 2. By reason of the fact that they did not exercise the license as it was granted by building the dam within the 10-year period. The court added that in its opinion it "did not see how it could specifically enforce the agreement since the plaintiff would not have title to all lands which would be inundated by the reservoir." The complaint was filed Sept. 11, 1959, by attorneys for the plaintiff, T. R. Conn of Lakeview and Ganong and Ganong of Klamath Falls. Also acting for the plaintiff during the hearing of the case was Hugh Biggs of the Portland firm of Hart, Rockwood, Davies, Biggs and Strayer. Attorneys for the defendant were Robert Nichols of Lakeview and Daly B. Robnett of Alturas.

# Farm Sale Pitch Told At Meeting

BALEM (AP)—There is need for a public relations program to picture the farmer as a solid person, Louie Wettstein of Ontario, president of the Oregon Dairy-men's Association, said today at its 67th annual meeting. "Labor groups who are out to organize our labor also are interested in changing the picture of the man on the farm. He is being pictured as a person taking advantage of labor and natural resources," Wettstein said. There is a need for research in the dairy industry, to promote the commodities of the industry and for closer cooperation among producers, processors and distributors so that each may have a fair profit, Wettstein said. He expressed concern over Social Security's setup and the non-employment of those over 65 years of age who could work, saying that soon one-third of the people will be supporting the rest of the population. Also mentioned by Wettstein as undesirable were some phases of the child labor laws which do not permit older children to do some types of farm work. Gov. Mark Hatfield spoke at today's luncheon, and explained his state government reorganization proposals as they affect agriculture.

Youngsters, up to age 18, are invited to participate. Winners in each of the various age-groups will receive ribbons. The course will be arranged by Ron Seator, a member of the U.S. Olympic racing team. Seator, a club member, says he will be willing to work with others in advising and preparing contestants for the race. Junior racers from Lakeview, Crater Lake, Ashland and Medford have been invited to compete. The race will be the first of several to be sponsored this year by the club, members say. Entry blanks will be placed at the ski bowl and at Divens Marine Supply and Sporting Goods, 123 North Spring Street, and The Gun Store on Main Street. Cost will be \$1 to those youngsters whose parents are not members of the club. Boys and girls in the categories for those 9 years of age and under and those 10 through 13 years of age will race together.
