

# Young Moundsmen Carry Giant Hopes

SAN FRANCISCO (AP) — The responsibility are southpaw Mike McCormick, 22, and right-hander Juan Marichal, 23.

McCormick, 15-12 last season, was the earned run king of the National League with 2.70. He signed his 1961 contract Tuesday for an estimated \$25,000, described by Giants Vice President Chub Feeney as a "very good raise."

Marichal, a poised second-year man from the Dominican Republic, was 6-2 and had a 2.66 ERA but didn't appear in enough games for eligibility for the title. He joined the Giants after mid-season and won his first four starts.

Feeney said he and Alvin Dark, the Giants' new manager, figure on McCormick and Marichal as the nucleus of the pitching staff. Among the others in the "solid six" are veteran right-handers Sam Jones, Jack Sanford and Stu Miller and southpaw Billy O'Dell. The big problem is dependable relief pitching and current plans are for Jones, Sanford and O'Dell to also work in relief.
