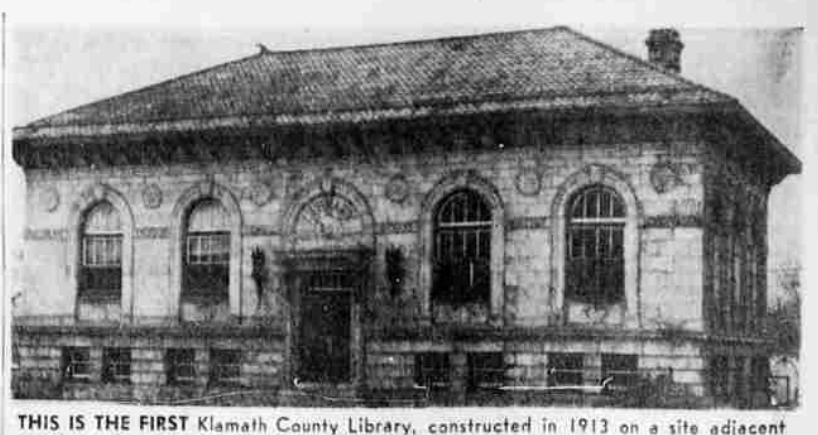




LIGHT AND CHEERFUL interior decor and a certain freedom to create sound make the county library a pleasant place to study or just spend some time looking around.



THE CITY LIBRARY was the result of long range planning on the part of interested women of the community. It was constructed in late 1926 and dedicated in February, 1927. It was built at a cost of about \$50,000.



THIS IS THE FIRST Klamath County Library, constructed in 1913 on a site adjacent to where the new courthouse was supposed to have been built, now the site of KUHS. It was the result of an agreement between the county court and the Carnegie Corporation. The building was razed to make way for the KUHS extension a few years ago.

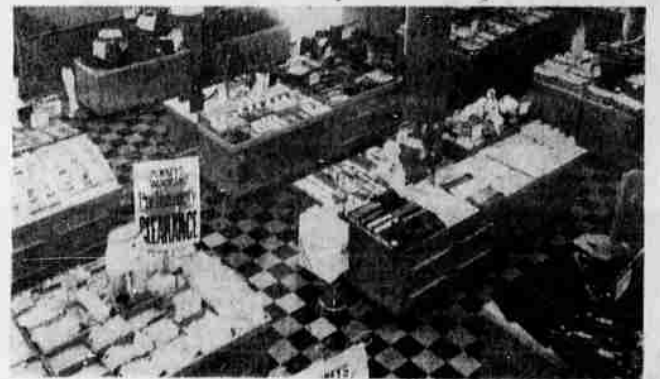

Klamath County Abstract was founded in 1905 by Joe Pearce and Allen Sloan. In 1906 Don Zumwalt, Bert Withrow and E. M. Bubb purchased the interest of Joe Pearce and incorporated the company, offering an Abstract & Escrow Service.

As the years passed, Sloan and Bubb sold their interests to Zumwalt and Withrow, and in 1924 Elbert Veatch purchased the entire stock of the company.
