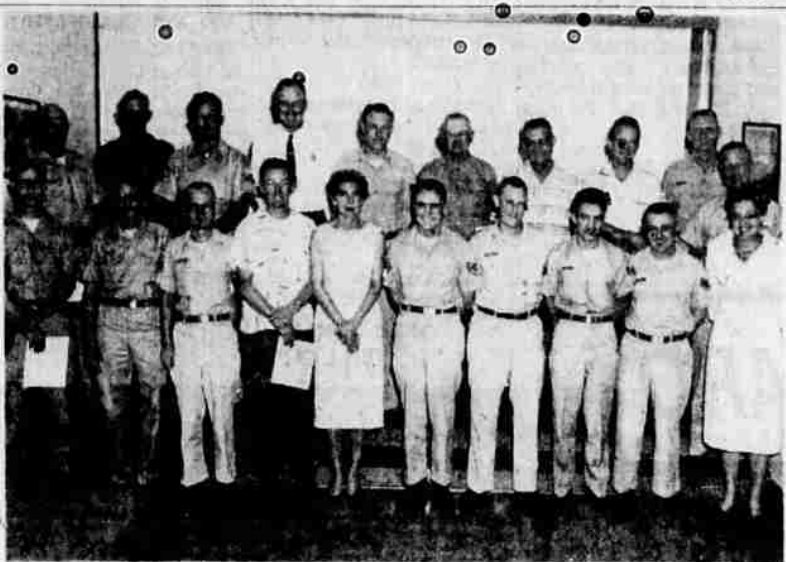

State Welfare Might Face \$4.8 Million Deficit

SALEM (AP)—A possible \$4.8 million state welfare deficit and initial action aimed at setting up medical care for the needy aged under the state Welfare Commission were reported Saturday.

Andrew Juras, acting state welfare administrator, told the legislative fiscal committee that the commission's medical subcommittee was leaning toward a medical care program under the commission.

This would mean that the aid to needy over-65-year-olds not on welfare would be administered as a vendor payment program by the commission staff. This, Juras said, still is not definite because the full commission has not acted upon it.

Juras spoke as the committee was considering a motion to look into the medical care spending in connection either with a contract plan to Oregon Physicians Service or a Welfare Commission program.

House Speaker Robert Duncan, D-Medford, moved to express the sense of the committee as in favor of the vendor program under the Welfare Commission.

Sen. Alfred Corbett, D-Portland, proposed a substitute motion of looking into expenditures to see that maximum aid is obtained.

Consideration was put off after Juras told of the subcommittee's action.

Juras told of the possible \$4.8 million deficit this biennium in talking about the aid to dependent children program. He said the figure was tentative and had not been presented to the Welfare Commission, which is now attempting to recast its entire welfare budget.

Juras said that \$22,132,973 was budgeted for the aid to dependent children and the best conservative

estimate now is for expenditures of \$28,945,860.

He said the deficit would require \$2,744,133 in federal money, \$1,420,138 from the state and \$600,596 in county money if it comes to pass.

The case load budgeted was 21,900, which he said was based on an increase rate of 5 per cent. He said the rate of increase over the past seven years had been running about 14 per cent.

Juras said that the most conservative estimate of the number of cases now is placed at 24,645. He said \$39 per case was budgeted but costs now are \$40 per person on ADC.

Juras said that beginning in October children of unemployed persons will be eligible for the aid to dependent children which will contribute to the added ADC cost. This is in line with action taken by Congress.

Juras said even with this major rise in aid to dependent children he was not prepared to say that welfare could not live within the amount given it by the legislature.

Prior to the presentation by Juras, Director Freeman Holmer of the Department of Finance and Administration said there is not now sufficient evidence to justify revising revenue estimates for the present biennium.

He said that the surplus carried over from the last biennium was \$32.5 million, which was \$2.8 million less than had been estimated.

Chairman Fred Hoefke of the state Tax Commission said that in the last biennium, which ended July 1, the state collected \$2.6 million less in personal and corporation excise and income taxes than it had expected.

He said the first two months of the present biennium showed a 4.1 per cent increase in personal income tax collections but a gain of 1.6 per cent in overall collections, which reflected lower corporate tax collections.
