

# Spud Parade Has Kandra As Marshal

MERRILL—Klamath Basin clubs, lodges, businesses and individuals have been invited to join in the 25th Annual Klamath Basin Potato Festival Parade. James Chance, parade chairman, announced this week.

The parade will assemble on Garfield Street near the elementary school grounds at 10 a.m. Saturday, Oct. 21. It will begin at 11 a.m.

Entries will march south to the highway, east to the Signal Station corner, north two blocks and west to the starting point, then disband.

Lewis S. Kandra, pioneer Merrill rancher and livestock producer, will serve as marshal and will be flanked by three riders, forming a diamond. Mrs. Maude Liskey and Vic Shuck will ride at the side and Mrs. Charles Dixon on riding her Tennessee Walking horse will ride in the back.

Entries will be judged on the parade route. Judges will observe how the entry adheres to the parade theme, if it has wide community interest, if it has eye appeal, quality and neatness; if the truck cab, if any, is covered and if the entry's framework is covered; how it is built and quality of lettering.

There is no real theme for the parade but the float should suggest the potato and harvest idea.

Parade classes are as follows: Class 1, commercial section (implements dealers, business and others)—first place, \$25 or cup; second place, \$15. Class 2, music section—first place, \$25; second, \$15. Class 3, organizations and lodges—first place, \$25; second, \$15. Class 4, youth organizations—first, \$25; second, \$15. Class 5, children's—first, \$10; second, \$5. Class 6, float—first, \$10; second, \$5. Class 7, mounted groups—first, \$10; second, \$5. Class 8, old automobiles—first, \$10; second, \$5. Class 9, individual mounted group—first, \$10; second, \$5. An individual interested in entering is urged to do so.

The sweepstakes-winning float will receive an additional \$25 or a trophy. Those planning to enter the parade are asked to contact Chance.

# Maher Asks Forest Fire Mark To Run Relief Seen

PORTLAND (AP)—State Rep. Kenneth Maher, R-Portland, today urged Gov. Mark Hatfield to make himself available for Republican nomination for president.

"If some action is not taken soon, we may find that we have frittered away our opportunity to produce the first Pacific Northwest president. The well-heeled older candidates are already moving in on potential presidential delegates," Maher said in a letter to Hatfield.

"I propose that we establish a Crusade Corps to take the Hatfield story to all 50 states. Allow me to volunteer as your first Crusader. Crusade Corps clubs can be set up in most major cities," the letter said.

"Allow me and Oregon to bear your own favorably," he concluded.

# Osborn Tries Plea Change

E. Gail Osborn, 40, former Klamath Falls civic leader, attempted to change his plea to a bad check charge from guilty to not guilty Thursday but District Attorney Dale T. Crabtree opposed the change without further information.

Osborn pleaded guilty on Aug. 9 in a charge of obtaining money and property by false pretenses. He admitted passing a worthless check on July 15 to Jack Bachman of the Sunrise Service Station. Police suspect Osborn of passing other checks totaling more than \$2,000.

Sentencing was originally set for Sept. 5 but Osborn was examined by a Portland psychiatrist, Dr. Henry H. Dixon Jr., on Aug. 22. According to Osborn's lawyer, the doctor found that Osborn was suffering from a mental illness and was not responsible when he wrote the bad check.

A motion was filed asking that Osborn be allowed to change his plea from guilty to not guilty by reason of insanity.

Crabtree said at the hearing Thursday that he was not convinced that there were sufficient grounds for a not guilty plea. He said Dr. Dixon's language, in two letters and a telephone call, was "not strong enough."

"This is foolish," the defense lawyer replied. He said it would be a "great injustice" if Osborn were not allowed to withdraw his guilty plea.

Judge David R. Vandenberg decided to study the law relative to the plea change and continued the matter until next Wednesday.

# Cuban Trip Okay Held

WASHINGTON (AP)—State Department officials declined Thursday to say whether the government would approve a trip to Cuba by president Harry Bridges of the International Longshoremen's Union and another union official.

They said no request had been received for validation of passports for such a trip.

The union announced in San Francisco that Bridges and William Ward, a member of the executive board, would attend a Cuban Federation of Labor meeting in Havana Nov. 11-13.

In Washington, State Department officials declined to say what the department's attitude would be if Bridges and Ward seek government clearance for such a trip. They said only that no request had been received for passports for the union leaders to visit Havana.

Last January, the department adopted a regulation requiring that U.S. citizens wishing to visit Cuba must have their passports specifically endorsed for such travel. The regulation was made after the break of diplomatic relations with the Castro regime.

Under the regulation, permission can be granted to persons whose travel could be regarded as being "in the best interest of the United States."

Asked whether a trip to Havana by Bridges and Ward could be viewed as being in the best interest of this country, officials advised reporters "to use your own judgment."

Applications normally would be submitted to the department's visa office in San Francisco. However, field offices usually forward "hot potato cases" to Washington.

LONDON (UPI)—Burglar Harry Crouch was dashing across the rooftops of London when he looked back and saw that a pursuing policeman had fallen through a skylight.

Crouch, 26, stopped running and went back to help policeman David Jones free himself, saying: "All right, guv'ner, I give up. I can't leave you to fall through there."

In court Friday the judge praised Crouch for saving Jones "at great personal risk to yourself," then sentenced him to 10 months in jail for burglary.
