David Haddock Recovers From Accident Injuries

A former Klamath Falls man, David Haddock, 25, now of Heppner, is recovering satisfactorily in a Heppner Hospital from injuries suffered Wednesday night in a traffic accident near Hardman, Ore.

The accident took the lives of two youths, Glen Vernon Finley, 19, driver of the car, and Robert Emil Johnson, 20, both of Pendleton and injured two other passengers. All were employees of the U.S. Forest Service.

Haddock, a forest service engineer, is the husband of Nell McFarlan, daughter of Mr. and Mrs. Charlie McFarlan, this city, and son of Mr. and Mrs. Hugh Haddock, now of Grants Pass, who lived for 14 years at 1528 Willford in Klamath Falls.

Young Mrs. Haddock, a registered nurse, assisted during Wednesday night with care of the three injured, all suffering from crushed chests and other hurts.

Mr. and Mrs. Haddock left here last June following Haddock's graduation from Oregon State University.

In telephone messages from Heppner, it was learned that Haddock had ridden down to Heppner from a remote forest headquarters with the younger men to visit his wife.

They were traveling on a desolate stretch of State Highway 207 when the car went out of control on an incline, sheared away a foot-thick tree as it plunged down a bank, then settled in three feet of water. Johnson was thrown into the water and apparently drowned according to the medical examiner for Morrow County.

Finley was thrown on top of the auto and died soon after the arrival of an autoist, stopped at the scene by Haddock. All three of the injured who were suffering shock and partial loss of use of their arms due to their chest injuries made heroic efforts to take Johnson from the water.

Doctors in Heppner indicated this morning that all three injured will recover. The car was wrecked too badly to determine the model.

Former MP Held Guilty

Frankie Joe Berry, 26, former Kingsley Field air policeman, was convicted of larceny Wednesday night by a circuit court jury which deliberated more than four hours.

Berry was convicted in connection with the theft on July 27 of part of a coin changing machine containing about \$40 from the Econ-O-Wash Laundromat, 3622 South Sixth Street. The 11-1 verdict was announced at about 9 p.m. to bring the three-day trial to a close. Judge David R. Vandenberg will sentence Berry at 10 a.m. Monday.

District Attorney Dale T. Crabtree, who handled the state's case, accused Berry of stealing the coin changing machine with an accomplice, Charles R. Hoxie, 24, also a former airman. Hoxie pleaded guilty last month and was sentenced to 18 months in the state penitentiary. He returned from Salem to testify at Berry's trial.

Berry's defense was that he wasn't in the laundromat on July 27. He said he was at the homes of Clarence J. Diem and Mrs. Nina B. Hunt and the local bus depot. The defense attempted to show that Hoxie would have had time to commit the crime by himself.

Hoxie, termed "a reluctant witness at best" by Crabtree, finally admitted that Berry accompanied him to the laundromat. The defense attorney moved for a directed verdict of acquittal on the grounds that Berry could not be convicted on the uncorroborated testimony of an accomplice. Judge Vandenberg denied the motion.

Other witnesses included Mrs. Hunt, Diem, Mrs. Elsie Berry and Patricia Seibert.

Police Query Man's Death

The apparent murder of Perry R. Benton, 54-year-old Alturas man, was still under investigation Thursday morning by city police and the district attorney's office.

Benton was found lying unconscious Sunday morning in a lot behind an old church at 626 Broad Street. He died Sunday afternoon in Klamath Valley Hospital from numerous skull fractures, according to doctors.

Police said there is a suspect in the case but the DA's office has not yet filed charges because of a confusion about the suspect's true name. The suspect, an itinerant Negro farm worker, has not been located.

Adult Education Night School Starts Monday

Following final action of the Klamath Union High School District Board of Directors, adult education in a night school program will be inaugurated at KUHS Monday.

C. E. Redfield, assistant principal at KUHS, announced that registration for the first section of courses will be held at the first class meetings Monday and Tuesday. All courses in the first nine-week section will be offered on those two days.

Redfield said response to a public survey published by the Herald and News indicated a tremendous interest in the program. Registration fee for all courses is \$10 he said.

Slated to be offered in the program, a first attempt at high school level adult education here, are high school English, beginning algebra, speech voice training, creative writing, wood shop, beginning typing, psychology and beginning clothing construction.

Openings exist in all but the sewing course, Redfield said, "over 50 women signed up for this course on the survey form." Registration will be on a first-come, first-served basis, he said.

Further information will be available from Redfield. All courses will be completed Dec. 18 and 19. The second session will begin shortly thereafter if sufficient interest is shown. Additional class offerings will be announced later.

Tea Party Debt Paid In Oregon

LONDON (UPI)—Jackson County, Oregon, today paid off its Boston Tea Party debt—\$1.96.

Seventeen Jackson County residents gave the \$1.96 check to an official of the London tea firm which lost a shipment in 1773 when Boston residents heaved it into the harbor.

"We are very grateful to the good people of Jackson County. Now we are waiting to hear from the rest of Oregon's counties and the other 49 states," said Leslie Simons, director of Davison and Newman.

Davison and Newman has been trying for 188 years to collect the \$4,966 debt. The British government has ignored the firm's petition for seven generations. "The government never gave us a penny, Bostonians simply smiled, but Jackson County—oh, they are fine folk," Simons said.

Mrs. Bert Pree, who headed the Jackson County delegation, gave Simons the check and a letter of explanation from Medford Mayor J. W. Snider. Medford is the "metropolis" of Jackson County, Snider said, and recognized the "long unpaid" debt.

Snider said Jackson County reckoned \$1.96 was its share of the debt figured according to the current U.S. population. Medford's mayor indirectly apologized for the famed Tea Party in 1773.

Snider said that in those colonial days Massachusetts and the East Coast "could hardly be considered civilized." However, Jackson County is "highly civilized" and willing to pay up, he said.

Simons said he is grateful and gave Mrs. Pree a package of tea for Mayor Snider. "I just hope she gets it through Boston. The people there are sometimes troublesome. We know," Simons said.

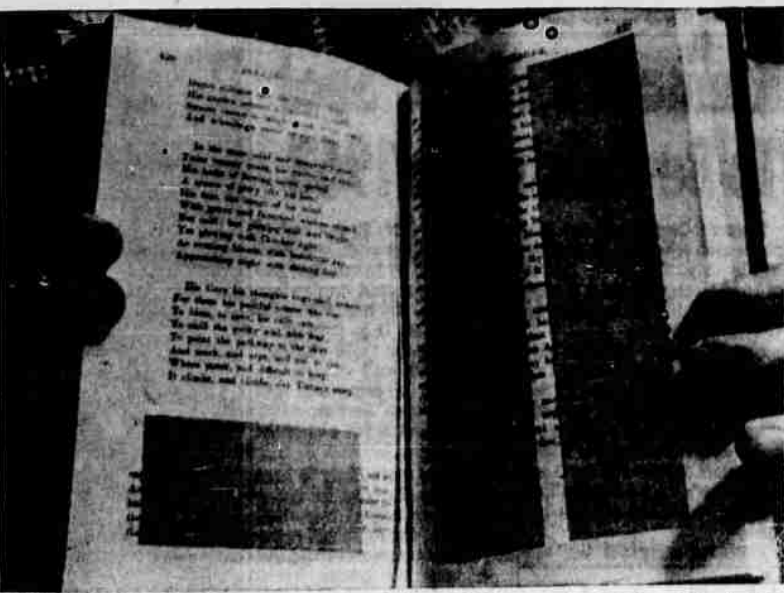
Police Look For Beaters

'Appreciative Audience' Enjoys Air Force Band At Pelican Court

For two hours Wednesday night the huge band filled Pelican Court at Klamath Union High School with music, ranging from a modernistic interpretation of Fourth of July fireworks to the familiar stirring passages of the most famous of all John Phillip Sousa marches, "The Stars and Stripes Forever."

LaMar K. Jensen of the KUHS Music Department estimated the audience at 1,200 and said he was "very appreciative" of the turnout. And the crowd, on its part, was most receptive to the band, directed by white-haired conductor, Col. George S. Howard.

Clad in black and white Air Force formal dress, the band opened the program with a version of "The Star Spangled Banner" that evoked mental images of "the rockets' red glare" above Fort McHenry.

Next on the program was the overture from "Patrie" by Georges Bizet, featuring interesting interplay between the flutes and clarinets. The band showed its versatility with a trumpet trio rendition of Victor Herbert's "The Three Solitaires" followed with a medley by H. Owen Reed called "La Fiesta Mexicana."
