From Washington:

Secretary of Defense Robert S. McNamara has told senators he believes ONLY HARM can come from their stormy investigation of the TFX warplane contract award.

He added:
"There is a lot of harm that will accrue from this investigation. I can not see ANY good that will accrue from it."

If you are an average, everyday citizen, not too familiar with the technicalities of politics and legislation, you may wonder what this TFX business is all about. Let's see if we can offer a little clarification.

TFX is one of those fancy alphabet terms that Washington is so fond of. It means TACTICAL FIGHTER, EXPERIMENTAL. This TFX is a fighter plane so designed as to be usable by ALL the branches of our armed services.

The idea back of it is that such a plane would save an immense amount of money and if properly designed and built would be just as effective as SPECIAL planes built for each service.

It's obviously a good idea if such a plane can be produced.

So—
Proposals to design and build such a plane were invited. Two proposals were received. One was from the General Dynamics Corp., of Fort Worth, Texas. The other was from the Boeing Co., of Seattle.

After an exhaustive investigation, the job was awarded to the General Dynamics Corp.

That's where the ruckus started.

It is a \$6.5 BILLION job. That's a lot of money. It represents an IMMENSE industrial development.

The General Dynamics Corp. plant at which the planes will be built is located at Fort Worth, Texas. The Boeing Co. has plants at Seattle and at Wichita, Kansas. Boeing had announced that if it won the contract it would build the planes at its Wichita plant. Presumably, its Seattle plant would have benefited materially—by the making of parts, and otherwise.

Naturally, Texas was acutely interested in getting an industrial development of such magnitude. So . . . in the accepted American manner . . . it called on its delegations in Washington to give their utmost to get the \$6.5 billion job for their state.

Both Washington and Kansas were equally interested in getting the job for their states. So the Washington and Kansas delegations in Congress came into the battle in a big way.

It was an epochal fight. Defense Secretary McNamara was the umpire.

He ruled for Texas and the General Dynamics Corp.

As every baseball fan knows, the umpire has a tough job. Secretary McNamara had a tough job. He is quoted as having said to the chairman of the senate sub-committee that held the final hearing and made the final decision:

"Last night when I got home at midnight, after preparing for today's hearing, my wife told me that my own 12-year-old son had asked her how long it would take for his father to prove his honesty."

So there's the story of this TFX ruckus that has been filling the papers and clogging the air waves for all these weeks.

It's quite a story, isn't it?

Job Riots Seen Threat

LONDON (UPI) — The festering unemployment problem, which set off a riot at the houses of Parliament, loomed today as a major threat to Prime Minister Harold Macmillan's government.

The riot by an estimated 3,000 unemployed Tuesday brought new demands from the opposition Labor party that Macmillan take firm action to ease the problem.

The Times of London called the storming of the government buildings "the wildest, most determined demonstration" outside Parliament since World War II.

The Daily Mail said it was the "biggest threat to Parliament" since the anti-Catholic riots in 1780.

Nine men were arrested and more than a score were injured after squads of 500 policemen broke up the riot and forced the demonstrators back out through St. Stephen's Gate, the main entrance to the houses of Parliament.

The trouble underlined one of Macmillan's major problems in a long list of issues that has had his government reeling for the past five months.

Reds Protest Exiles' Attack In Cuban Port

MOSCOW (UPI) — The Soviet Union today lodged a formal protest with the United States against the "piratical attack" by Cuban exiles on a Russian ship at a Cuban port last week.

The official Soviet Tass news agency said the note charged the attack took place March 17 against the Soviet ship Lgov at the Cuban port of Isabela de Sagua.

It said that Cuban rebels, whom the Communists call "counter-revolutionaries," approached the ship in a launch and fired several bursts from a heavy machine gun.

At the time, spokesmen for the Cuban exile group known as "Second Escambray Front—Alpha 66" claimed credit for the attack against the Soviet ship, but said it occurred about dawn March 18.

(President Kennedy said at his news conference last week that such attacks could cause more harm than good.)

The note forwarded to the U.S. Embassy here said the government of the U.S.S.R. expects "the government of the United States to take resolute measures for preventing similar provocative acts in future," according to Tass.

The Soviet note said that without the U.S. government's "material support" and the supply of American weapons and ships, "the handful of traitors" to the Cuban people who have taken refuge on the territory of the United States could not have engaged in provocations of this kind.

Tass quoted the note as saying the United States is in fact leading matters to "a dangerous aggravation" of the situation in the area of the Caribbean and throughout the world.

It said the Soviet government declares that the responsibility for

the actions of Cuban "counter-revolutionaries," including their attack on the Soviet merchant ship, rests entirely with the government of the United States.

Encouragement of these actions by the United States "is contrary to the agreement reached between the governments of the U.S.S.R. and the United States on the adjustment of the crisis in the area of the Caribbean," the note said.

Cuban exile spokesmen in Miami and New York said at the time that opponents of Premier Fidel Castro shot up a Russian freighter and a nearby Soviet army camp in twin attacks.

Engravers Make Peace With Papers

NEW YORK (UPI) — Publishers and striking photoengravers came to terms early today, all but ending a newspaper shutdown of almost three and one-half months in the nation's largest city.

Police Halt Vote March By Negroes

GREENWOOD, Miss. (UPI)—An estimated 100 Negroes were scattered today by police and a police dog as they marched on the LeFlore County Courthouse to register to vote.

One man was arrested by police for refusing to move on.

Police said they dispersed the crowd because it was "blocking traffic" and the sidewalks of this north Mississippi town which has been the scene of racial violence in the past several weeks.

Two shotgun blasts were fired Tuesday night into the home of the father of Negro Dewey Greene Jr., who recently was denied admission to the University of Mississippi.

No one was injured by the blasts which shattered glass in a front door and window at the home of Dewey Greene Sr.

An intensive Negro voter registration campaign has been under way in the Greenwood area since a Negro registration worker was wounded last Feb. 23 by a blast fired from a moving car.

Today, the large group of Negroes appeared at the Greenwood City Hall and were ordered to disperse by Mayor Charles E. Sampson.
