

# Six Periods Of Tennis Instruction Planned; Program To Start June 24

The following tennis instruction program schedule was released by the Klamath Falls Parks and Recreation Department to dispel any confusion regarding the program in the wake of the city council's action to continue the program on a fee basis despite the fact that sign-ups were deemed too few to cover instruction expenses.

The program will run from June 24 to Aug. 2 with six separate periods of instruction. A session for 12 adult women will be held Mondays, Wednesdays, and Fridays from 10 a.m. until noon if anyone registers for the instruction. As of June 18, the department reported that there have been no registrations for this class. The fee is \$7.

Only two youngsters are registered, as of June 18, for the Monday, Wednesday, and Friday 1 to 3 p.m. classes. This instruction period is limited to 12 children and the fee is \$7.

The semi-private instruction for children that runs from 3 to 5 p.m. Monday, Wednesday and Friday is filled with six already registered. The fee for this instruction is \$8.50.

No adults registered for the semi-private Monday and Wednesday evening classes that are open to six adults from 6:30 to 8:30 p.m. The fee for this session is \$5.

Another full class is the Tuesday and Thursday 1 to 3 p.m. period with 12 children already registered. The fee for this instruction period is \$3.50.

Three children registered for the session on Tuesday and Thursday from 3 to 5 p.m. There are openings for three more in this class and the fee is \$5.

Interested persons can still sign up at the Moore Park Courts at the time the class they are interested in is being held.
