Raiders Belt Patriots 24-17 As Football Season Starts

OAKLAND, Calif. (UPI) — The 1963 Oakland Raiders were on a one-game winning streak today, but coach Al Davis warned all that needs help—and plenty of it.

"The Raiders knocked over the Boston Patriots, 24-17, before 9,721 paying fans and about 5,000 others at Frank Youell Field Sunday.

"I'm surprised with the showing our boys made," said Davis after the victory. "And I'm happy with the win."

"But we have a long way to go. We need a lot of help. We have some good players, but we need more."

Needs Talent

This is the Raiders' fourth year in the American Football League and Davis is the first to admit that his club probably won't be a contender—unless someone trades him some talent.

The team lost 19 games in a row in 1961-62 going into the final battle, when it upset Boston.

"The help probably won't be needed at quarterback, where Cotton Davidson put on a fine performance. He completed 16 out of 34 attempts for 251 yards and one touchdown. Tommy Flores, who will share the signal-calling duties, completed four out of six during the short time he was in the game, good for 83 yards.

"But he lost a contact lens after

a pass interception, and he never got back into the battle.

And there'll be no help needed at one end spot where Art Powell, who played out his option with the New York Titans last year so that he could join the Raiders, caught nine tosses for 123 yards and one touchdown.

Matsos Strong

Another strong spot is at middle linebacker, where Archie Matsos, a five-year veteran, was a ball of fire. He rammed through the porous Patriot offensive line time and again to throw ball carriers for a loss. He batted down passes. And he intercepted one and returned it 23 yards to the Boston 17.

"I don't know if it was the best game I ever played," grinned Matsos after the game. "But I liked it."

Before the game, coach Davis had been worried about his defensive line. But it played the Pats off their feet during the first half, when the Raiders built up a 7-0 lead on Davidson's 24-yard touchdown pass to Powell.

Lead Changes

Boston tied it up on a 23-yard aerial from Tommy Yewic to end Art Graham early in the third. The Raiders went ahead on Durward Pennington's 46-yard field goal, but the Patriots came right back on Gene Cappalletti's 16-yard field goal.

A passing attack featuring Da-

vidson and Bo Roberson carried the ball 71 yards on the next drive, with Davidson sneaking over from the one to give Oakland a 17-10 lead after three quarters.

Boston tied it again on a 57-yard pass featuring Yewic and Cappalletti, but Davidson passed to Powell on the one to set up the winning touchdown after Matsos' interception midway in the last quarter. The score came on a one-yard drive by fullback Charley Rieves.

"I would say they were further along in their training than we were," said Boston coach Mike Holovak after the game.

AL Gridders See Toughie

The results of the American Football League's opening exhibition games indicated this could be a tough year for the top dogs.

The Kansas City Chiefs (nee champion Dallas Texans) and the Houston Oilers, Eastern Division titlists, were surprised in the AFL's first pre-season clashes Saturday night.

Paul Lowe, who sat out the 1962 season with a broken arm as San Diego reeled to a 4-10 record, scored twice against Kansas City as the Chargers swept to a 26-14 victory and their 13th straight exhibition win without defeat since the league was founded four years ago.

Rookie quarterback Mickey Slaughter of Louisiana Tech threw two touchdowns in Denver's 27-10 upset of Houston.

The Oakland Raiders, who snapped a 13-game losing streak by beating Boston in the last game of the 1962 season, upended the Patriots, 24-17, Sunday.

Four exhibition games are on tap next weekend — Houston vs. New York at Shreveport, La., and Kansas City entertaining Buffalo on Friday night, Boston at San Diego Saturday night and Denver at Oakland Sunday.

In the National Football League, Dallas is at Los Angeles on Thursday while in Saturday exhibitions, Baltimore plays Philadelphia at Hershey, Pa.; Chicago meets New York at Ithaca, N.Y.; Detroit hosts Cleveland; Green Bay faces Pittsburgh at Miami, Fla., and Minnesota takes on San Francisco at Portland, Ore.

Rule Battles Kidney Attack To Win Tourney

ST. PAUL, Minn. (UPI) — It didn't take young Jack Rule Jr., long to learn the layout of the Kellor Golf Course and when the chips were down he remembered every blade of grass.

"I had no feel at all," the 24-year-old Cedar Rapids, Iowa, resident said. "I played from memory."

Rule fired a 206, three off 263 for 72 holes.

There was some doubt whether Rule would have a chance to play the final round of the \$35,000 St. Paul Open Sunday and a notch his first professional tour victory. He had shot a record-setting 61 Friday to take a six-stroke edge after trailing by three shots at the end of the first round.

But Saturday night while

having dinner at a local restaurant, Rule suddenly suffered extreme pain in his kidney area. He was taken to a hospital where his ailment was diagnosed as kidney stones.

He showed up Sunday just an hour before tee-time to defend his seven-stroke lead in the final round.

"I felt very weak," Rule said after pocketing the \$5,300 first prize money. "Even as far as 17 I still felt I might not finish."

The victory came in Rule's second year as a pro and raised his season's earnings to \$13,424.50.

Fred Hawkins, who trailed Rule by seven strokes going into the final round, fired a one-under 71 to finish second at 271. Dave Hill, Jackson, Mich., and Bruce Crampton, Sydney, Australia, were at 273 and George Bayer, Pasadena, Calif., at 274.

\$10 Million Libel Suit Opens Today In Atlanta

ATLANTA (UPI) — A \$10 million libel suit brought by former Georgia Athletic Director Wally Butts against the Saturday Evening Post begins in federal court today.

Butts' suit was sparked by a Post article last March called "The Story of a College Football Fix."

The trial will get under way in the courtroom of Judge Lewis Morgan. Picture taking and broadcasting of the trial proceedings are forbidden.

A 12-man jury with two alternates sitting in will decide if the Post article printed March 23 libeled Butts when it said that the

former athletic director gave away information on key Georgia football plays and formations to rival coach Paul Bryant of Alabama. The Post story quoted Atlanta insurance man George Burnett as saying he was accidentally connected into a telephone conversation that took place between Butts in Atlanta and Bryant in Tuscaloosa, Ala. The alleged conversation, the Post article said, took place Sept. 13, 1962, nine days before the Georgia-Alabama game in Birmingham, the opening contest for both teams.

Burnett, the story said, made hurried notes of the purported talk between Butts and Bryant. These are expected to figure prominently in the trial.

Alabama was a 17-point favorite in the game and won, 35-0.

Both Butts and Bryant issued heated denials of the Post story and both filed multi-million dollar libel suits. Bryant's suit against the Curtis Publishing Company magazine was filed as a separate action.

Sonny announced in Philadelphia Sunday night that unless some tax-relief arrangement with Uncle Sam can be made in advance of his proposed big-money fight with Cassius Clay at Philadelphia Municipal Stadium, Sept. 30, the Clay fight must wait until next year.
