East's queen of hearts won the first trick and he returned the eight. West went up with ace and cleared the suit by leading the seven.
The hand looked simple enough at this point, but after South cashed the ace and queen of clubs, East was unkind enough to show out.
At this point most players would have decided that conditions were bad everywhere and just given up but one South, Paul Levitt of Sioux City, Iowa, had other ideas. In spite of the fact that the three of hearts had not appeared, Paul was sure that West had opened a five-card suit and had the ace of diamonds as a sure entry. He had also shown up with four clubs so he was likely to be short in spades.
Paul cashed the ace of spades, entered dummy with the king, noting that West had dropped the ten. He led a third spade and finessed his nine. When it held Paul was a clover.
He cashed the queen of spades and watched West drop the nine of hearts. His first discard had been the ten of diamonds.
The three of hearts was still missing, but Paul had already made up his mind where that card was. Hence West was down to a singleton ace of diamonds. Paul led the low diamond. East cashed his ace and that three of hearts, but Paul made the last two tricks with the minor suit of kings.
