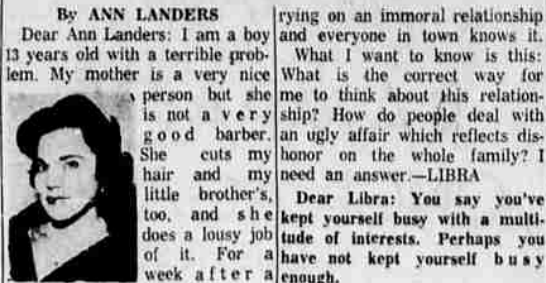
Civil War Claim Sought
