

# Field Trip To Ken-Del Ranch Highlights Meeting Of Christmas Tree Growers

TENNANT — Christmas tree production on a sustained yield basis in the natural habitat of the premium silvertip tree was demonstrated last Saturday to the California Christmas Tree Growers Association.

The field trip, a feature of the two-day association convention, was taken on the Ken-Del ranch owned by the father-son partnership of Kenneth and Ronald Bishop. It showed the pruning and thinning methods developed by the Bishops which have resulted in production of 42,000 bushy, symmetrical silvertip trees on 700 cultivated acres.

The 40-mile trip over back roads took the 125 convention members to the 6,000-foot slopes that ring the north side of Mt. Shasta. The Bishops, with the cooperation of the U.S. Forest Service, the California Division of Forestry, and others, arranged for 35 vehicles capable of traveling the rough roads built for managing and harvesting the trees.

Various stops were made during the day-long trip to show hybrid experiments under way, trees in various stages of growth,

and regrowth potential from stump culture. Verne Osburn, Redding, California Division of Forestry, assisted in the "show me" tour, and Bill Riddiman, Siskiyou County agricultural adviser, handled convention arrangements.

The convention started on Friday in Mount Shasta with Howard Neilsen of Santa Cruz, association president, presiding. Tests on shipping and storing Christmas trees, conducted by the University of Oregon, were described at the dinner at the Mount Shasta Rod and Gun Club. Melvin Conklin, University of Oregon professor of agricultural economics, illustrated his talk with color slides.

A list of "choose and cut" developments is now available to individual tree cutters at the Christmas Tree Growers Association office, 12500 Empire Grade Road, Santa Cruz, the association secretary announced.

Various aspects of the Christmas tree industry were discussed at the Friday afternoon meeting at the Mount Shasta city park. Robert Aiken of Weed, represent-

ing Southern Pacific Land Company, described the Christmas tree program on his company's holdings in northeastern Siskiyou County.

Frank Bath of Mount Shasta, speaking for the Hoffer Christmas Tree Company, warned association members of dangers of opening silvertip thickets with heavy pruning and subjecting the trees to too drastic a change in growth conditions.

Thomas Glunt of the Shasta Forest Company, Redding, explained his company is developing a dual program with timber and Christmas tree production. Glunt told of the growth in popularity of family tree cutting, saying over 5,000 trees were cut on Shasta Forest Land with individual permits last year.

The association is looking to help curb illegal tree cutting and transporting of Christmas trees in California. Assemblywoman Pauline Davis (D-Portola) and Paul Lunardi (D-Placer County) were praised for pushing through a measure which makes mandatory the filing of bills of sale

with the sheriff's office in the county where the trees are cut. H. N. Abernathy, sheriff of Plumas County, explained that each truck load of trees must also have a transportation permit obtained through sheriff's offices, and this permit must be validated en route at the nearest law enforcement office.

"We want to make the market available to the legitimate businessman," Abernathy said of the new protective laws.

## Blowdown Situation Improved

PORTLAND (UPI) — A mild spring and a cool summer have been helpful factors in the timber blowdown situation, a lumber official said Tuesday.

W. D. Hagenstein, executive vice president of the Industrial Forestry Association, said an estimated 17 billion board feet of timber was knocked down in the region by the Oct. 12 and subsequent winds.

He told a Keep Oregon Green luncheon that the mild spring allowed salvage of 2 to 3 billion board feet and because of this the lumber strike this summer did not materially hurt the overall salvage effort.

Hagenstein said the cool summer proved unfavorable for the dreaded bark beetle, but that beetles still remain a threat.

An increase in lightning-caused fires this summer was noted but the overall acreage burned on state and federal land is about the same as last year, despite the blowdown danger, forestry officials said.

State Forester Dwight Phipps said that because of the blowdown, some areas may be open by permit only to deer hunting.

## OSU States Foods Test

CORVALLIS (UPI) — Oregon State University announced today it will soon begin a five-year program to test foods for use in fall-out shelters.

The school received an \$88,000 grant last year to study storage of a dried whole wheat wafer that had been developed as a survival ration. A \$32,000 federal grant was added recently to allow the school to study 12 foods that might make the water taste better.

They include raspberry jelly, a strawberry spread, cream of chicken soup, beef soup, oriental sauce, curry sauce, paprika gravy, chili sauce, apple topping, butterscotch topping, chocolate pudding and wild cherry frosting.

The foods will be stored at various temperatures for five years, with panels of students tasting them every six months and registering their likes and dislikes.

## THE DOCTOR SAYS Hypertension On The Increase

By W. G. BRANDSTADT, M.D., Newspaper Enterprise Assn. To some persons this may be the atomic age or the space age. To others, it is the hypertensive age.

Hypertension (high blood pressure) is increasing, not only in prevalence but also in the number of factors that seem to produce it, or to be closely associated with it.

Certain tumors of the glands of internal secretion, hardening of the arteries, kidney disease, some kinds of brain tumor, and the toxemias that complicate pregnancy (eclampsia, etc.) may cause it. But in the majority of persons whose blood pressure is high, the cause is unknown.

It is a mistake to assume that a high blood pressure reading indicates heart disease or a poor outlook for the future. A little exertion, a little excitement, or a mild feeling of uneasiness or apprehension will usually send the pressure way above the arbitrary normal.

That is why, when your doctor gives a high reading, he is likely to have you rest for a few minutes.

Then, when he takes it again, it will often be found to have returned to normal, or at least to have come down to a lower level.

It has become a popular saying among doctors that the best way to lower your blood pressure is to take it again. When your doctor takes your pressure he will always record two readings.

The upper level, the systolic pressure, is that which results from the powerful thrust of blood into your arteries when you exert heart contracts. The lower level, the diastolic pressure, is the level to which the pressure falls just before the next heartbeat.

The systolic pressure is much less stable than the diastolic. Systolic pressure shoots up rapidly with work or excitement and comes down just as rapidly with rest or a return of calm. The diastolic pressure is much more stable and therefore more important. When it goes up, it usually stays up, and when it stays up this may be a warning that serious hypertension will develop in time.

Many persons whose blood pressure does not come down after a rest are still able to lead active lives and survive to a ripe old age, but because in others the hypertension is progressive and may lead to an early death from malignant hypertension, the insurance companies have no choice but to raise the premiums on all persons with a high or even an unstable blood pressure.

In addition to the factors already mentioned, heredity may play a part in high blood pressure. Obesity is surely a factor, and the pressure normally increases somewhat with age. Women show a greater tendency to high blood pressure than men, but they seem to tolerate it more readily.
