New Mark Taken By Wright

ST. LOUIS, Mo. (UPI)—Sticky Wright established single season records for money earned and most tournament victories during the 1963 Ladies Professional Golf Association (LPGA) tour.

The long-driving Californian, who now plays out of Dallas, Tex., won 13 of the 28 tournaments in which she competed and earned \$31,269.50 in official prizes, according to figures released Monday by the LPGA.

The old record of 10 tournament victories for the lady pros was set in 1959 by Betsy Rawls and equaled by Miss Wright in 1961 and 1962.

Miss Wright, in becoming the first woman golfer to crash the \$50,000 mark in earnings, erased the old single-season record of \$26,744.39, set by Miss Rawls in 1959.

Kathy Whitworth, of Jal. N.M., played in all 28 LPGA tournaments this year, collecting eight titles and finishing second among the money winners with official earnings of \$26,850.

Duke Figure Winner Of Atlantic Conference

By ROBERT S. McNEILL, RALEIGH, N.C. (UPI)—Duke is minus the great Art Heyman, but the Blue Devils are expected to muster enough power to win their second consecutive Atlantic Coast Conference basketball title.

The word at Duke is "Art Heyman's gone but Jeff Mullins is back," and that just about sizes up the situation—enough to make the Blue Devils the power of the South.

While Duke is seen as the king pin of the ACC, the Davidson Wildcats, West Virginia Mountaineers and Virginia Tech are expected to be the main forces in the sister league, the Southern Conference.

Davidson has center Fred Hetzel who set several records for the Wildcats last season as a sophomore—the most points, best scoring average, best field goal average, best rebound average and the most rebounds.

If any team is able to whip Duke in the ACC, it is expected to be North Carolina, which comes complete this season with its star of last season, center Billy Cunningham, a junior, who averaged 22.7 points per game last year.

Also expected to finish among the leaders is Clemson, which comes into the season after several years of low-caliber basketball. But the Tigers have four starters back from last season, when they won 12 and lost 12, led by guard Jim Brennan who averaged 16.6 points.

After four consecutive years as a finalist in the ACC tournament, Wake Forest hopes luck dial. But if Wake Forest Coach Bones McKinney has troubles, he should talk to Coach Everett Case of North Carolina State. The Wolfpack has won the ACC title four times since the conference was organized in 1953, but this year the usual powerhouse just isn't in sight.

Maryland, South Carolina and Virginia all hope to put together better records than they did last season, but none of them is expected to offer much that can dislodge the Duke-North Carolina-Clemson predominance.

WESTERN MOUNTAIN STATES
By ROBERT S. McNEILL, DENVER, Colo. (UPI)—The Western Mountain States Conference is expected to be a close race between the University of Colorado and the University of Utah.

Colorado is expected to be the favorite to win the conference title, but Utah is also a strong contender. The Buffaloes have a strong backcourt and a solid frontcourt, while the Utes have a powerful offense and a strong defense.

Other teams in the conference include the University of New Mexico, the University of Idaho, and the University of Nevada. The conference is expected to be a competitive one, with several teams capable of challenging the top two.
