\$6.5 Million Approved For High Voltage Intertie

WASHINGTON (UPI) — The Senate Appropriations Committee recommended Thursday \$6.5 million for construction of extra-high-voltage transmission lines to carry power from the Columbia River to the Pacific Southwest.

But the committee directed that the construction start after the intertie is connected through the existing Hoover, Parker and Davis dams and with the proposed Bridge and Marble Canyon dams in Arizona.

The legislation has been passed by both the Senate and the House, but is bogged down in controversy over a House amendment to the legislation.

The Senate committee recommended appropriation of \$5 million to purchase land and equipment for the power intertie and an additional \$1.5 million for preliminary engineering.

Two Line Intertie. The committee said the two-line intertie should connect the BPA system to the Central Valley Project power system at Tracy, Calif.
