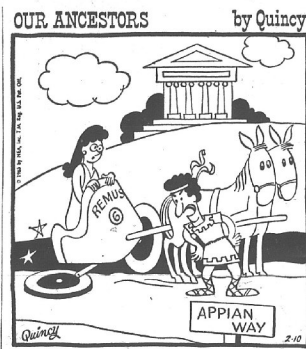

Snowpacks Up Outlook For Water

LAKEVIEW — The general outlook for Lake County as reported by the USDA Soil Conservation Service shows abundant water supplies for Lake County irrigators in the coming season, although they are very wet soils and reservoirs full to the brim.

The water content of the mountain snowpack, as measured about Feb. 10 at 18 stations, is 150 per cent of the 1948 - 62 average and 116 per cent of last year. This abundant snowpack rests on water-saturated soils that are retaining the moisture saturation point. These wet soils will favor runoff from snowmelt next spring.

Both Deeds Valley and Cottonwood reservoirs are full and spilling. It has been estimated by an experienced water engineer that over 200,000 acre feet of water have run into Cottonwood Lake since Feb. 1.

Streamflow forecasts for the March - June period are higher than for many years and are as follows: Cottonwood, 1,000 cfs were 172 per cent of average; Deep Creek, 11,000 cfs were 140 per cent of average; Honey Creek, 22,000 cfs were 178 per cent of average; Twentymile Creek, 32,000 cfs were 139 per cent of average.

The inflow to Deeds Reservoir is expected to be 100,000 cfs for the March - July period, 132 per cent of the 1948 - 62 average.

Group Moins Safety Plan

SALEM (UPI)—A House committee has begun consideration of a bill to create a group of military, civil defense, State Police and Motor Vehicle Departments under a director of public safety.

Freeman Holmer, state finance and administration director, told lawmakers the proposal would make the agencies "more immediately responsible to the governor, less costly and more effective."

Rep. Richard Greener, D-Milwaukie, demanded to know from the bill whether the director would have a law of coordination between agencies, or if they were cut off from communication with the governor.

"I don't think there's any room for improvement," said State Police Chief S. M. Jones. Holmer replied that the governor believed in coordination.

LBK Okays Atom Cuts

WASHINGTON (UPI)—The Atomic Energy Commission (AEC) has announced that President Johnson has approved a new cut in the production of atomic energy.

The AEC said the new cut would reduce the production rate by 10 per cent, from 10,000 to 9,000 metric tons of uranium oxide per year.

The new reduction brings the total cutback in such production to 60 per cent when added to the 40 per cent cut in uranium production announced last year. Last year the AEC also announced a 20 per cent decrease in the production of plutonium 239, another atomic fuel and explosive.

AEC stressed that enough uranium explosives and fuels will be produced to meet weapons and power requirements. In future years, when civilian nuclear power production has increased, it will be necessary to raise production again.

The new cuts will affect production of the three gas diffusion plants which fissile uranium 235 is separated from natural uranium ore. The AEC said the new cuts will cost about 100 jobs at the plants, located at Oak Ridge, Tenn., Paducah, Ky., and Portsmouth, Ohio. Personnel reduction will be accomplished by the internal reorganization of the plants.
