"A Covenant with Death" by You join culture clubs and... Stephen Becker is a novel with more impact than is usual in strike, picket, stand up and fiction. Indeed it is a beautiful literary indictment of "We, the People."

The story is of the southeast, in 1922, when a man is charged with the murder of his wife. It is told by a judge, then only 29 years old, whose personal biases and conflicts are mirrored in the decision concerning the guilt of the accused man.
