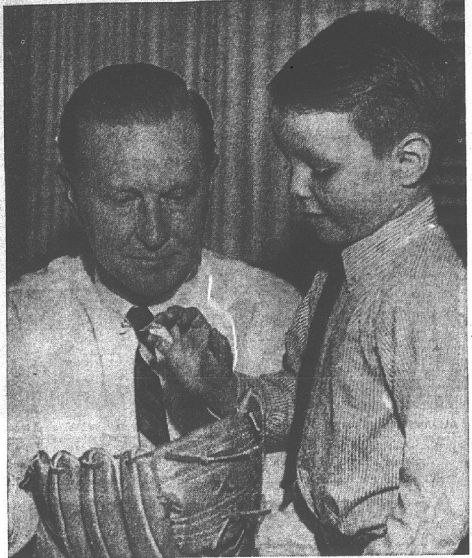

That may be too much to ask. But Musial has unbowed faith in his former roommate. "I've seen Red work with ballplayers before and he has a natural knack for getting his message across," says Stan Musial.

"He's at his best with young players and we have a lot of them," adds Musial, who is the vice president with the club and will offer occasional batting tips as he did last spring.

Admires Plate — "There's no doubt in my mind Red will do a fine job. What I admire most about him is his patience. That's an important quality for a manager. I've seen a lot of managers who don't have it. Especially if they happened to be outstanding players themselves. They always expected everyone to be at least as good as they were."

Schoendienst was plenty good during his playing days. Good enough to make nine All-Star teams, finish a 300 lifetime batting average for 19 seasons in the majors and establish numerous fielding records for National League second basemen.

Peletta Has Key To Protection Against Cage Player Fixes

BERKELEY, Calif. (UPI) — Coach Pete Peletta of the powerful Santa Clara University basketball team has his "secret" method to protect his cagers from gamblers.

"We have a rule on the road that the players cannot receive incoming telephone calls," Peletta told Tuesday session of the Northern California Basketball Writers and Broadcasters. "And when the fellows leave the hotel, they must go in pairs."

The discussion about gamblers was triggered by a pending investigation into alleged point shaving by Seattle University.

Coach Mike Cimino of St. Mary's told the meeting that basketball as such is not to blame.
