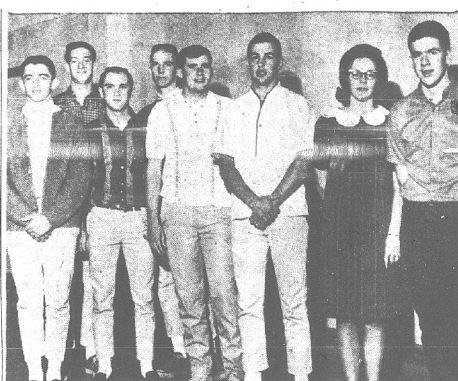

### Mrs. Oswald Claiming Fatal Rifle

DALLAS (UPI)—Marina Oswald claimed the legal rights to her dead husband's property, the most valuable piece of which was the mail-order rifle Lee Harvey Oswald used to kill the president of the United States. Marina was appointed to handle Oswald's estate by Probate Judge F. W. Bartlett Jr. She was bonded for \$5,000. An appraiser of Oswald's estate valued the 6.5 millimeter Italian military rifle that fired the fatal shot into President Kennedy's brain and the 38-caliber pistol Oswald used to kill policeman J. D. Tippit at \$10,000 because of their historical interest. Also listed in Oswald's estate was a diary, a four-power telescopic sight, a two-piece sling and a cartridge clip all of which were brought into light by the assassination. The property was awarded Marina a year and four months after Oswald was shot in the basement of the Dallas police station by Jack Ruby. William Blaylock, attorney for Mrs. Oswald, said she was anxious to sell the items listed in the estate in order to provide security for her and her two daughters. He said he had already received a \$10,000 bid on the pistol and the rifle from a gun collector. The department of Justice is currently holding the weapons. "I don't think the government has any right to keep them since the Warren commission has finished its job," said Blaylock. "They belong to Mrs. Oswald and her children."

### Legion Wins Conflict With Group

PORTLAND (UPI)—The American Legion vs its battle with the Beales for use of the Memorial Coliseum here Aug. 22. The long-haired English singing group had been booked into the Coliseum for that date, but American Legion officials said it conflicted with the scheduled Legion national convention Aug. 26-28. M. M. Mesher, Beale promoter, said however, he would file a court action Monday to force the Portland Exposition Recreation Commission to live up to its commitment. Legion officials had threatened that the group might pull out of Portland completely for the big national convention. Bob Hazen, local Legion official who headed a corporation that worked four years to bring the convention here, said the Legion needed that date to move into the Coliseum.

### Vatican Probes Stand On Controlling Births

VATICAN CITY (UPI)—Pope Paul VI Saturday held his first meeting with the international Roman Catholic Church's stand on birth control. Most Vatican circles said the commission's recommendations are not likely to lead to any radical change in the church's position. The Pope announced last year that the church would study the question of its traditional ban on artificial methods of contraception. The impetus for the study was scientific advances in birth control, including contraceptive pills.

### Legion Wins Conflict With Group

Some sources said the commission, which has eight American members, was divided into three groups: in favor of permitting the pill to augment the "rhythm" method of contraception approved by the church; in favor of even wider use of the pill; and opposed to any change. If the last view prevails, Catholics would be permitted to control family size only through abstinence in marital intercourse or by restricting relations to infertile periods of the month — the rhythm method.

### U.S. Mediators Begin Talks To End 12-Day Glass Strike

ATLANTIC CITY, N.J. (UPI)—Federal mediators Saturday began round-the-clock negotiations in an effort to get an agreement in the 12-day strike against most of the nation's glass container manufacturing plants. "There are many modifications and issues to be settled before we can count on being home safely," observed federal mediator William Rose. Rose met jointly with officials of the striking Glass Bottle Blowers Association and the Glass Container Manufacturers Institute until 3 a.m. Then he contacted the two sides separately throughout the day. "We're going to continue on a tireless, accelerated pace," Rose said.

Lee W. Minton, president of the union, said that with the committee on hand quick approval would be possible with an acceptable industry offer. The union's new proposals, in addition to points contained in a previous management offer, called for a "meaningful wage increase" the second year, 50 minutes of relief on machine jobs, and 40 weeks of guaranteed work for employees with 10 years or more of service. The previous offer called for a 10-cent-an-hour wage increase the first year, insurance and pension benefits the second year, and a 3 per cent wage boost on base earnings the third year. The U. S. Labor Department Bureau of Statistics lists the average hourly wage in the industry at \$2.92. The strike has closed 64 plants of 22 companies. It threatens to diminish sharply the nation's supply of food glass containers. Some 32,000 workers have been idled.

TRUTH ABOUT LYE  
NEW YORK (UPI)—Most city people know lye only as something used to clean out bathroom or kitchen drains when they are clogged. But lye has other uses. Virtually everything on a dairy farm, for example, is sprayed with a lye solution, from maternally stilled livestock, to milking stools, chains, crocks and ultra modern milking machines. According to Dr. J. L. Perlman, director of research of B. T. Babbitt, Inc., one of the major lye producers in America, "lye has been the farmer's friend for half a century."

### DOWNTOWN PARKING

Why not make downtown a real shopping center, instead of de-centralized by outlying businesses? Our property taxes are becoming unbearable and we need relief.
