IN THE NAME OF THE STATE OF OREGON: You and each of you are hereby notified that Klamath County, a body politic and corporate of the State of Oregon, is the holder of certificates of delinquency issued to it by the tax collector of Klamath County, State of Oregon, pursuant to the statutes in such cases made and provided, which said certificates are bound in book form as required by law. That the said certificates of delinquency as hereinafter set forth in this summons were issued by the sheriff and tax collector of Klamath County, Oregon, on the 27th day of June, 1919, for the year 1915, and were filed by said tax collector in the office of the county clerk of said Klamath County on June 27th, 1919; that thereafter other certificates of delinquency were issued to Klamath County by said tax collector and filed in the office of the county clerk for taxes delinquent for years subsequent to 1915, as are hereinafter set forth, indicating the several dates and taxes respectively. That after the said several delinquencies had accrued, and prior to the issuance of said several certificates of delinquency respectively, due notice of said several delinquencies was given, as required by law. That complaint and application for judgment to foreclose said certificates was filed in the above entitled court and cause on the 28th day of July, 1924.

That in addition to the taxes included in said certificates of delinquency for the year 1915 and for the years subsequent to 1915, as indicated, there are due to this plaintiff certain interests on said several amounts at 12% per annum from the date of the issuance of
