HISTORIC PAC. MAIL LINE MAY **BE DISSOLVED**

SAN FRANCISCO, April I - Sale of five transpacific liners by the cluited States shipping board to the Dollar line, may mean the dissolusion of the historic old Pacific Mail Steamship company, which for more 75 years has been identified shan. with the commerce and romance of the Pacific.

Announcement was made here on Wednesday by Daulton Mann, assistant general manager of the comowny that unless officials of the company now at Washington find some means to prevent the sale of the riners now flying the Pacific Mail clag, there is nothing left to do but for his company to liquidate and go out of business.

Older than the state of California. the Pacific Mail's flag was first moisted to the masthead of a sidewheel steamer April 12, 1848.

It was a Pacific Mail steamer, the Oregon, that brought news on Octoper 18, 11850, that California had te en admitted to the Union.

The Pacific Mail Steamship comwany was incorporated in New York with an initial capital stock of \$500,wee, it prospered, and in 1855 recapitalized for\$ 20,000,000.

The first steamer to fly the 'Mnil' theg was the California, 800 tons. which left New York October 6. 1848, and made the initial trip via The straits of Magellan.

With accommodations for but 100 possengers, the steamer carried 100 men in whose eyes gleamed the lust for gold. Three hundred of them in the privilege.






