

NOTICE OF BOND SALE

Sealed proposals, will be received by the Common Council of the City of Klamath Falls, Oregon, for the purchase of \$50,000.00 worth Municipal Bonds, authorized by an election duly held November 4th, 1924, and by Ordinance of the City of Klamath Falls, Oregon, number 650, issued for the purpose of buying the ground and building thereon a City Public Library and reading room with Ladies' Club and Rest Room.

Proposals to purchase such bonds will be received by the Police Judge up to and including the 15th day of May, 1925, at the hour of 3:00 o'clock P. M., and opened at a regular meeting of the Common Council of the said city immediately thereafter. The said bonds to be dated February 1, 1925, and in denominations of \$1000.00 each, payable serially in 12 years.
