“FIGHTING CHAPLAIN” TO LEPER ISLE TO DEVOTE HIS LIFE

to the outside world. He was an expert leper, and he met it in the same spirit that made his war record so conspicuous.

“I can make one single unfortunate happy, my errand will be a great success,” he said simply.

Father d’Orgeval is one of a number of Catholic priests who have come to this leper island in the Hawaiian group on a similar mission. He was born in Lyons, France, in 1872, studied music before taking up the cloth and was a priest of Paris for many years.

As the plucked, scathed leper looked into the smiling eyes of the

“strange little man” who voluntarily had condemned himself to a living death, the heroic story of Father Damiens, a Belgian priest was recalled.

One of the first churchmen to enter upon duties at the leper isle, Father Damiens, contracted the disease and died here.

“My work is done and I am happy,” were his last words. And, too, there is the story of Brother Charles Dutton, one time dashing cavalry officer who threw away social prestige, wealth and comfort and came here from New Orleans to spend the rest of his life with the “lost prisoners.”

“Have you ever regretted your decision?” he was asked a few days ago.

Does one ever regret doing a kindly deed? he queried in reply.
