GERMAN OFFICER RETURNS EMBLEM TO PARENTS OF AMERICAN BOY HE KILLED DURING ARGONNE FIGHTING

PHILADELPHIA, July 25.—A little silk American flag carried by a Philadelphia youth when he was killed two months before the armistice has just been returned to his family by a member of the German company at whose hands he fell while fighting in the Argonne.

Corporal G. W. Fryling was a member of the Twenty-eighth division. Before Fryling sailed his brother, S. H. Fryling of this city, sent him the flag, with the request that he carry it into every engagement. If the soldier brother came back alive he was to return the flag to the donor as a war token.

"Corporal G. W. Fryling was killed in action in the Argonne forest Sept. 26, 1918," read the message

his family received from the war department. The body was returned to this country, but the flag was missing.

A few days ago S. H. Fryling received a letter from A. Scheffele of Gerellingen, Germany, a lieutenant in a German regiment that fought in the Argonne, inclosing Corporal Fryling's flag, which the American soldier had placed in an envelope bearing his brother's address. It had been found on the battlefield.

"I took the flag with the intention of returning it after the war was over, but as I was sent to the hospital myself, the envelope was mislaid until recently," wrote the former German officer.
