Oakland, Cal., became the comedienne's sixth wife Tuesday before Judge William H. Clark, of the Hartford probate court.

The two slipped into Hartford from Boston shortly after noon and took out their license. Hopper gave his age as 66 and Miss Glazer hers as 29. After the marriage, they left for New York.

Judge Clark kindly arranged to waive the five-day law, which would obstruct the marriage of most couples from outside the state and performed the ceremony in his own chamber. He refused afterward to say whether Hopper had trembled or just merely yawned.

One time, the fifth time to be exact, Hopper was married for 11 years to the same woman, Elda Furry was the wife who held the fickle DeWolf so long, but you will recognize her more readily under her stage name, Hedda Hopper.

Elda Gardiner was the first Mrs. Hopper and Ida Mosher was the second, but that was long ago. Then Hopper married Edna Wallace, who still is known by a combination of her own name and the one he gave her, and some persons have even referred to Edna Wallace Hopper as the "62-year-old flapper."

MOTHER CLAIMS SON NOT BAD BOY

Youth Who Shot Mother and Killed Father on Trial For Shooting

ALLISON, Iowa, Oct. 20.—(United News)—"My boy," began Mrs. Della M. Vandervort as she testified at the hearing here Tuesday to determine what punishment shall be meted out to her 17-year-old son Warren, for the murder of his father. "My boy was a good boy. There was just something the matter with him when he did it."

Suffering from bullet wounds inflicted by the "flaming youth" for whose life she is pleading, the broken mother paused after saying Warren was a "good boy." Apparently this was a fact that everybody else was ignoring, and one which ought to be emphasized.

And then she went on to deny that their home had been divided by the wrangling between herself

and her husband, the late Vandervort, as Warren had come out of his room that morning and had shot his mother and father so that he might get their insurance, also was claimed by the mother.

Mrs. Vandervort spoke at first, but as she gained of her feelings, her voice more firmly. She seemed to lay all the facts before the

Reverting to the statement "something was the matter with Warren," Mrs. Vandervort that last summer, just before murder she had been impressed by her son's strange conduct, spoken to the family about it, she said.

The question of Warren has been taken up briefly, coupled with the fact that defense witnesses are claiming "character witnesses" in defense may not employ the plea to save the youth's gallows.
