WILD WEST GUN PLAY DEPLORED

Law Officers Frown on Too Ready Display of Gun For Minor Offenses

Once more gun play figured in the arrest of a local man for an alleged misdemeanor, when Fay Laurie, holding a temporary commission from the sheriff's office, was said to have discharged his revolver twice early Sunday morning prior to the arrest by County Traffic Officer Knowles of James Farrell, accused of possessing liquor.

Knowles plainly showed his attitude toward the use of firearms under such circumstances, when he testified in court, before Judge H. H. Bunnell, that he had promptly commanded Laurie, who chanced to be with him, to "lay off that stuff."

YEGGS CRACK BOX GET \$350 IN COIN

Klamath Falls Creamery Is Robbed for Fourth Time On Sunday Night

A crime wave rippled over Klamath Falls early yesterday morning and, when members of the sheriff's office and the police had checked on results, they found that burglars had attempted three "jobs," only one of which might be termed successful.

Safe-crackers so expert that they gained entrance to the inside of a safe without dislodging its door, entered the Klamath Falls creamery, across from the White Pelican hotel, and escaped with \$350 in cash and checks. Two hundred dollars of the money was in silver and currency, it was said.

It was the fourth time that entrance has been gained to the creamery, according to Glenn Kent, manager.

The proper amount of "soup" was placed in the safe after it had been removed to the ice room in the rear of the building. According to veteran detectives, the amateur safe man either endeavors to knock off the knob of the safe with some heavy instrument, or usually uses too much of the "soup." Frequently objects in a room are considerably damaged when the amateur tries a "job," but in the local case only the inside of the safe was damaged.

Local police said, however, they believed the work to be that of amateurs.

Two other establishments were broken into some time Sunday night. Into the rear part of the warehouse of the Sixth street grocery store went burglars who, had they entered the front part of the establishment, probably would have met shell fire at the hands of Tom Gurne, watchman. Gurne, he said yesterday, heard them make their entrance and calmly waited for them to appear at a point where he could get a shot at them. Apparently, however, they were frightened away, for their exit followed close on their appearance.

Nothing was disturbed at the Mills Implement company, located at the corner of Sixth and Klamath streets. Belief was expressed by J. S. Mills that these burglars, probably the same ones who entered the grocery store nearby, were again frightened. Mr. Mills leaves nothing of value in his safe, and his combination is posted where any thief might discover it.

The Mills burglary also was perpetrated late Sunday night or early Monday morning, for T. W. Smith, employe of the company, left the building Sunday night with everything in an orderly condition. When Mr. Mills arrived at his establishment early yesterday, he found the front door unlocked, but he is unable to say whether or not entrance was gained there.

The contents of the Klamath Falls creamery safe was fully insured, according to Mr. Kent.

The Burden of Klamath

An Editorial

It is more than unfortunate that Klamath is unable to consider more dispassionately its important problems making for progress. This condition is serious. It is serious because on every occasion requiring clear insight concerning the prosperity of this community an attempt is made to disguise the real issues in the minds of the unthinking. Cuttle fish tactics are the rule. A black cloud of ink, just ink, is used to keep concealed the real facts, and truth is not a factor.

The real facts, known too well by old residents, are the selfish and questionable purposes actuating those who are attempting assumption of control. Never in the history of the west has the progress and prosperity of a community been so hampered by leaders so traitorous to the public interest and so unscrupulous as to their private ends. Klamath county is heavily handicapped and can only progress in full measure when it throws off the burden.

Just now the attempt happens to be directed at the coming election of two directors on the board of the Klamath irrigation district. Next week it will be something else; any public question will bring forth a contemptible cacophony. Temperate utterance would be so unexpected from these false leaders of Klamath Falls as to justify suspicion.

In connection with this irrigation election the successful farmers, bankers and merchants have requested this newspaper to present the plain truth to the voters. And The News sees it as a public duty to accede, and assist the great body of water users who are in open revolt against the policies of the board as dictated by its president, R. E. Bradbury, and his supporters.

The deplorable condition of the district calls conclusively for the suppression of the president of the irrigation board. He and his group have so antagonized those from whom relief might be expected that they are now ignored by Washington. As a result the entire district suffers and will continue to suffer unless the Bradbury-Eberlein candidates are overwhelmingly defeated.

KEYNOTE STRUCK FOR CONGRESS BY NICK LONGWORTH

Middle West Hears Party Issues

PROGRAM IS OUTLINED

Senate Talks Too Much But House Does Not, Says Speaker-Elect

CHICAGO, Nov. 2.—Nicholas Longworth, speaker-elect of the house of representatives, and son-in-law of former President Roosevelt, delivered to the middlewest Monday night a message from the republican administration in Washington.

Longworth's address before the women's republican Roosevelt club, was regarded as the keynote of the next congress.

He outlined this program of legislation:

1. Economy throughout, but not at the expense of the army or navy.
2. Tax reductions of approximately \$400,000,000 with the surtax cut 20 per cent, the bill becoming law before Christmas.
3. —Unyielding opposition to the LaFollette farm bloc of the northwest, excluding "progressives" from important committees.
4. Further strengthening of the immigration laws, and no tampering with the tariff.

Regarding Vice President Dawes' campaign to revive the rule of the senate, barring filibusters, Longworth declared the senate talks too much, but that the house does not.

"It is my opinion," said Longworth, "that no tariff law or laws touching taxation ever can be passed in this country which will not be attacked and criticised, often quite legitimately. But I do not hesitate to affirm that the existing tariff law is working most satisfactorily. The principle of this law will not be abandoned so long as I am speaker of the house of representatives."

Longworth said that while abroad this summer he visited legislative bodies of European countries, "where you see the practical working out of bloc or group government."

"I don't like the system," he said. "I like stability and responsibility. We had a taste of bloc government in the last congress. The bloc was sufficiently large in combination with the minority party, to overthrow the majority, as it occasionally did."

"At the last election the people repudiated this sort of thing by a huge majority, but owing to peculiar conditions in their states the gentlemen were returned to congress."

"Acting under this mandate from the people we have excluded these gentlemen from participation in party councils."

Longworth added that the republicans have "left the door open" for the "progressives" to return to the party when they decide to work in harmony with it.

MILLION-A-DAY FLORIDA GAIN

Bank Resources Increased \$116,000,000 In Four Short Months

TALLAHASSEE, Fla., Nov. 2.—(United News)—An indication of the size of the tide of gold that is sweeping into Florida, bringing with it unprecedented prosperity, was revealed here when State Comptroller Ernest Amos, announced that the resources of Florida banks had increased at the rate of more than \$1,000,000 a day between June 30 and September 25, this year, which is usually a slump period for the state.

The resources of Florida banks increased, \$116,000,000 in the stated period, Amos announced.

Total bank resources on September 25, were \$478,000,000, while a year ago they were \$179,000,000.

RED CROSS BUSY ON DRIVE PLANS

Matrons and Young Ladies Aid Solicited for City Residential Work

Local Red Cross chapter officials are now busy with preliminary plans for the annual roll call this fall, according to Mrs. Howard R. Perrin, chapter chairman of the drive here.

"The roll call, Mrs. Perrin added, is the annual enrollment of Red Cross members through which the work of the local chapter and the national organization work of the society is financed."

Tentative plans call for the house-to-house canvass of the entire residential section of the city as well as the canvass of the business houses. The aim of the solicitors will be to visit personally every resident of the community and enlist his support.

Mrs. Perrin hopes to have the help of the Boy Scouts in the house to house canvass as well as matrons and young ladies living in the various sections.

Mrs. Perrin, who is one of the prominent social welfare workers of the city, said yesterday that she felt the American Red Cross to be our most effective instrument for helping the unfortunate in our community. This is the ninth annual roll call and it is hoped that it will be as successful as the others held throughout the country when Klamath did her share by showing a full quota.

The big drive opens on Armistice Day and will continue through the month to Thanksgiving Day.

Democratic Leaders Predict Plurality

NEW YORK, Nov. 2.—(United News)—New York's mayoralty campaign came to a close Monday night, with a flurry of last minute activities and speeches designed to get out the vote in Tuesday's elections. The vote is expected to seat Senator James J. Walker, democrat, in the mayor's chair by a big plurality.

Democratic leaders variously predicted Walker's plurality would be anywhere from 100,000 to 450,000. Political observers declare the majority of democratic candidates will be swept into office with Walker.

At the headquarters of Frank D. Waterman, republican candidate, however, it was predicted that the wealthy fountain pen manufacturer would replace John F. Hylan, the present incumbent.

Sedan Overturned Occupants Escape

Dr. and Mrs. W. J. Rhynsburger, their daughter and her eight months' old baby suffered a narrow escape on the Green Springs highway yesterday when their heavy Chandler sedan caught in a strip of loose gravel and swung them off the highway completely turning the car over.

The party are residents of Los Angeles on a pleasure trip to Klamath Falls.

With the exception of Dr. Rhynsburger, who suffered minor cuts, the remainder of the family came out of the ordeal unscathed and the baby "came up smiling."

The entire top of the car was smashed out, the back section torn loose and the glass work of the car practically demolished.

\$140,535 NEEDED TO RUN CITY FOR YEAR IS REPORT

City Council Receives Budget Figures

LIMIT IS MAINTAINED

Ward 5 Committee Given Power to Act on Relief From Water Nuisance

It will cost the city of Klamath Falls no less than \$140,535 to conduct its business during the year 1926, according to the tentative budget, last night received by the budget committee, at the regular meeting of the city council.

The aldermen, in making up the allotments, barely kept within the six per cent tax limitation law.

In its report, the budget committee recommended that a city manager and commissioners be considered for the future. Its contention was that Klamath Falls is growing so rapidly that the city council system will not serve properly.

To the street committee last night went a proposal to repair the Esplanade canal bridge where, it was said, considerable attention is necessary. The committee was voted power to act as it sees fit.

The street committee also will probe into a complaint registered, through a petition, by six citizens residing in the vicinity of Oregon avenue and Fulton street. All are residents of ward No. 5, and stated that, during the rainy season, water congregates in their neighborhood and floods their basements and cellars. In the case of ward No. 5 the committee also was given power to act.

Last night's meeting of the council was a prolonged one, and a great deal of routine business was transacted. Many persons were granted permits to erect new buildings, and a number of bills were ordered paid.

An ordinance, instructing the police judge to call for bids on the new city library, to be erected across from the city hall, was read for the second time. The old ordinance, presented for a third time, authorizing the mayor to enter into a contract with C. C. Kennedy, engineer, for a preliminary survey of the sewer situation in the city, also was read for the second time.

PROGRAM MARKING TIME
