MUST WORK OUT SALVATION ACCORDING TO BELIEF OF AGRICULTURISTS REPORTING SITUATION

Administration at Washington Expected to Maintain Hands-Off Policy, Based on Reports from Investigators

CONGRESS IS INTERESTED IN CONDITIONS

WASHINGTON, Nov. 6.—The middlewestern farmer must find his own salvation.

CAMPBELL RITES ARRANGED SOON

Services Await Arrival of Daughter in City From Los Angeles

Arrangements for the funeral of the late John Campbell, who died suddenly early Thursday afternoon, are pending, awaiting the arrival of the eldest child, Miss Alice Campbell of Los Angeles, according to word received in the city yesterday afternoon. Miss Campbell is scheduled to arrive in the city Sunday evening.

John Campbell died suddenly of angina pectoris, a disease of the heart, from which he had been suffering for the past six months. His death was a shock to his hundreds of friends even though his health had been failing for some time. He is survived by his daughter, Alice of Los Angeles and three young sons, Bruce, Paul and Gordon, all attending school in Klamath Falls.

Coming to Klamath Falls in 1911, Mr. Campbell established himself in the Klamath Hardware company of which he has been owner and manager since that time. His business associates and those with whom he came in contact in private life feel keenly the loss of their friend who passed away so suddenly.

Zaragoza to Be New Name of Tiajuana

PUBLICITY LAW IS UP FOR REPEAL

Proposal on Foot to Strike Clause From Statute Exposing Incomes

WASHINGTON, Nov. 6.—Repeal of the income tax publicity law has been voted by the house ways and means committee.

This action was taken Friday in the course of the committee's work in drafting a tax reduction bill.

It proposes to strike from the state books the compulsory publicity clause which has caused more indignation and criticism than any act of congress since the Volstead law. The chief complaint has been that it exposed the personal finances of individuals to salesmen, business rivals, and curious persons without fulfilling its ostensible purpose of reducing tax evasion through publicity. Opponents of the clause have insisted that because of the broad exemptions in the tax law, the size of the tax does not correspond with any regularity to the size of the income.

The publicity clause was inserted in the present tax law in 1923 through the pressure of the LaFollette insurgent group, which then held the balance of power in both houses. They received democratic support and the aid of some progressive republicans. President Coolidge protested with much vehemence against this clause in signing the bill. With the republicans safely in control in both houses, it is probable now that the repeal favored by the house committee will succeed.

In addition to this action, the committee also refused Secretary Mellon's request that estate taxes be abolished. It compromised by cutting the present 40 per cent maximum in half. Retention of this source of revenue was forecast Thursday when the committee raised the exemptions on the moderate tax payers.

FLOWER'S MANAGER SUSPENDED IN N. Y.

NEW YORK, Nov. 6.—(United News)—Indefinite suspension of "Walk" Miller, former manager of "Tiger" Flowers, negro middleweight, was announced Friday by the New York state boxing commission. Miller was suspended for charging that Jack Delaney, Bridgeport middleweight, had something in his glove besides his hand when he knocked out Flowers in New York early this year.

PRESIDENT ROBS BANK TO PAY TAX DUE FOR 5 YEARS

Threat of Prison Is Cause of Act

TAKES LONG CHANCE

Forces Banker to Accompany Him to Edge of Town With \$10,000

DAYTON, Ohio, Nov. 6.—(United News)—"I robbed the bank to keep out of prison," confessed Elliot Gabler, 30-year-old president of the Gem City Engineering company of this city, and son of a prominent Dayton family. Gabler is under arrest on the charge of having robbed Philip Kloos, manager of the East Dayton branch of the City National Bank and Trust company of \$10,000.

Gabler said he had not paid his income tax for five years, and was threatened with imprisonment by the government so he took a long chance to clear his financial difficulties. As he had done business with the bank for a number of years, he knew the general custom of its officers. Awaiting his chance, he disconnected the gas line from Kloos' automobile and when Kloos, who was transferring the money to the main bank, had reached a spot only a few blocks from the bank, his car stopped. Kloos was examining the engine when Gabler drove up in a Hliver alongside and compelled Kloos at the point of a revolver, to enter the Hliver with him and drove to the edge of town.

Gabler is the second manufacturer-bankit caught within three months after robbing bank employees to pay personal obligations.

Fred C. Nickel, former prominent Dayton manufacturer, is serving from 10 to 25 years in the Ohio penitentiary for robbing the North Dayton branch of the Dayton Savings and Trust company of \$25,000 on August 14.

After Gabler confessed he had held up Kloos, he told of another attempt against the man a week ago. The first attempt failed last Friday.

WOMAN OF 60 PLOTS KILLING OF SISTER, 78

HOLLYWOOD, Cal., Nov. 6.—Feeble, white haired Mrs. Nellie B. Fortune, 60 years old was lodged in jail here late Friday night charged with plotting the deliberate murder of her 78 year old sister in law.

According to police charges, she offered two taxicab drivers \$500 if they would chloroform Mrs. Gertrude Fortune and throw her body from their car at some lonely spot. The arrest was made on information supplied Hollywood police by George Jones, taxi chauffeur.

NECK IS BROKEN.

HOBOKEN, N. J., Nov. 6.—(United News)—Injured in a football scrimmage during a scrub game near his home last Tuesday, Edward Engler, 17, died Friday of a broken neck and internal injuries.

CRIME CAREER OF CHURCHMAN ENDS IN DEATH

CHICO, Calif., Nov. 6.—The short crime career of Fred C. Crummett, church worker and respected farmer, has been ended by suicide.

Unsuccessful in an attempt to rob a United States mail truck bearing a \$2500 payroll, Crummett hanged himself by a suspender belt, from an upper bunk in the Chico jail early Friday.

Crummett has been identified prominently with a local church, and, with his wife and two children, had lived a quiet life on an almond ranch. Authorities are at a loss to explain why he donned a pair of false whiskers and, armed with a revolver and black jack, attempted the hold-up.

He was not in need of money, it has been shown.

ACCIDENT VICTIM IS GRANDSON OF KLAMATH CO. MAN

Judge and Mrs. Emmitt Leave For San Francisco to Attend Funeral

Word was received in the city late last night of the death of F. L. Martin, grandson of Judge and Mrs. R. A. Emmitt, who died in a San Francisco hospital, following an automobile accident in which he received a fractured skull and other injuries which proved fatal.

Martin was the son of Mrs. Horace Myers of San Francisco, known to her many friends in Klamath Falls as Georgia Emmitt. As a child Martin was born and reared on the Emmitt ranch near Keno. Judge and Mrs. Emmitt are leaving this morning for San Francisco to attend the funeral of their grandson.

Martin was 27 years of age at the time of his death. He is survived by his mother and stepfather, Mr. and Mrs. Horace Myers, a wife and four small children.

The accident occurred when an automobile which Martin was demonstrating collided head-on with a street car near Ocean Beach early yesterday. Five persons were injured and ten months' old baby escaped without a scratch. Martin died several hours after the accident occurred.

FEDERAL OFFICERS NAB HIGH GRADERS

SAN FRANCISCO, Nov. 6.—Four persons, including two women, were arrested by federal agents Friday and charged with disposing of \$15,000 worth of high grade ore, which had been stolen from an Amador county gold mine.

It is alleged that the gold was removed by "high graders" over a long period and that the quartette under arrest moved it slowly into the United States mint here.

That the operations of ore thieves in California mines have increased greatly in recent months was indicated by the federal report that about \$500,000 worth of the amalgam has been stolen this year.

MAN WHO SAW CUSTER'S LAST RIDE ENDS LIFE

BILLINGS, Mont., Nov. 6.—John Burkman, 86, who saddled Gen. Custer's horse Victor, for him, and was the last survivor to see the general ride into the battle of the Little Big Horn, where the command was massacred June 25, 1876, was a suicide victim here Friday.

Burkman, despondent over being refused admission to the soldiers' home at Sawtelle, Calif., fired a bullet into his brain and died instantly in his apartment at a local rooming house.

LOSES LAND, SUICIDES

OTTAWA, Ont., Nov. 6.—As a final, eloquent protest against what he believed was rank injustice on the part of the Canadian government, Auguste Swanson, an aged Scandinavian, shot and killed himself in a corridor of the parliament building Friday.

Swanson tried for fifteen years to regain a homestead in Manitoba which he had lost, and which litigation through all the courts failed to restore to him.

CARLETON-DREW BACKERS THROW ADDITIONAL LIGHT ON TAX MANEUVER

Records Held Changed in Order That Eberlein Land Might Escape Taxation By District, Check-mating Legal Foreclosure

The heartfelt interest taken by the Bradbury board in the affairs of Charles Wood Eberlein, who with his railroad money, is back of the administration campaign to retain itself in office, was yesterday given a new throb by the Economy in Office club members who are backing G. H. Carleton and Charles Drew in an effort to unseat Bradbury.

It is set forth that shortly after the new board came in power that records were changed in order that Eberlein's land might not be taxed by the district. This was long before the date of the now infamous Bradbury order which relinquished taxes, penalties and interest totaling about \$2,000, as shown on the books in the tax collector's office, and forestalling by a few days the plan of the tax collector's office to foreclose.

But here are the facts, as known to the Economy club executive committee:

Under the Fact Finder's bill provision is made for appointment of a local committee to act as a land classification board. Individual land classifiers were appointed to classify the project lands. J. R. Dickson, a prominent and very competent farmer, member of the district, was appointed for the district directly south of Klamath Falls by the local board.

Dickson classified the holdings of the Enterprise Land & Investment company and placed them in the producing and paying class. He reported to the local classification board. These gentlemen arbitrarily changed Dickson's classification and placed the Enterprise lands, the same 85.8 acres on which the taxes of \$2,000 were relinquished, in sixth class, or the "permanently to be excluded class."

This move was subtly intended as warranting justification for relinquishing the Enterprise water users. But it was discovered, and other water users who refused to carry the Enterprise burden entered protest.

Acting on this protest two government soil experts made an investigation, and placed this land back in the paying classes as originally reported by Dickson, a classification they still hold.

It was after this re-classification that Bradbury, yielding to the importunities of Eberlein, blocked foreclosure by the tax collector, and signed the order of relinquishment. Thus, an added load was placed on the already heavy tax burden of the district.

Eberlein, explaining in his paper, the said messings with his 85.8 acres, becomes eloquent. He says: "This case is perhaps the most extreme in its lawlessness and disregard and contempt of property rights that has occurred in the long and vicious history of the United States Reclamation Service."

To which Klamath county will respond, "Amen!"
